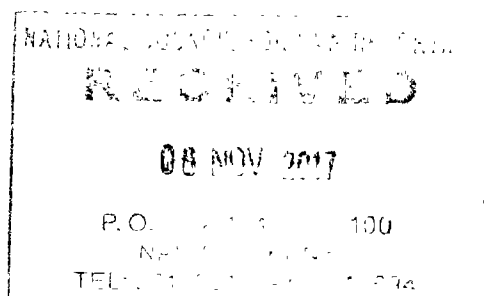

**THE SUPPLEMENTARY APPROPRIATION  
(NO. 3) ACT, 2017**

**No. 33 of 2017**

*Date of Assent: 13th October, 2017*

*Date of Commencement: 16th October, 2017*

**AN ACT of Parliament to authorize the issue of certain sums of money out of the Consolidated Fund and their application towards the service of the year ending on the 30th June, 2018, and to appropriate those sums for certain public services and purposes**

**ENACTED** by the Parliament of Kenya, as follows—

1. This Act may be cited as the Supplementary Appropriation (No. 3) Act, 2017, and shall come into force upon publication in the Gazette.

Short title and  
commencement

2. The Treasury may issue the sum of ninety seven billion, three hundred and sixty four million, nine hundred and twenty nine thousand, four hundred and sixty four shillings, out of the Consolidated Fund and apply it towards the supply granted for the service of the year ending on the 30th June, 2018.

3. The sum granted by section 2 shall be appropriated for the several services and purposes specified in the second column of the First Schedule, in the amounts specified in the third column of that Schedule.

In addition to the sum granted by section 2, the sum specified in the fourth column of the First and Second Schedules shall be applied for the several services and purposes specified in the second column of those Schedules, out of revenue directed to be applied outside the Consolidated Fund under Article 206(1) (b) of the Constitution.
