Terms of Reference

- Within fourteen (14) days of receipt of applications under subsection consider the applications to determine their compliance with the provisions of the Constitution and this Act; shortlist the applicant and interview the shortlisted applicants.
- Prepare a merit list of two most qualified candidates for each position and submit the names to the Governor.

Tenure

- The tenure of the panel shall be determined by the date of appointment of the member of County Executive Member Committee upon approval of the County Assembly.

Remuneration

- The remuneration of members of the panel, secretariat and support staff shall be as per the applicable Salaries and Remuneration Commission's guidelines contained in the relevant circulars.
