1. The Government of the Kingdom of Lesotho has received a loan from the African Development Bank (ADB) towards the cost of Education II Project and intends to apply part of the funds to cover eligible payments under the contract for the construction of new government Primary Schools in Lesotho, No. P/S-4 (i to xv). Bidding is open to all bidders from eligible source countries as defined in the ADB's Rules of Procedure for Procurement of Goods and Works.
  
2. The Kingdom of Lesotho which has designated the Principal Secretary, Ministry of Education to undertake this work, now invite bids from eligible bidders for the Construction of classrooms, Administration block, kitchen and stores, latrines and associated site works at the following Primary Schools identified under this project consisting of fifteen (15) slices as detailed below comprising:

4. It shall be mandatory for bidders based in Lesotho to submit Tax Clearance certificates from the Departments of Income Tax and Sales Tax, together with their bids. The documents shall be either originals or certified copies from the respective Departments. Non-compliance to this requirement will invalidate the bids.
