TENDER NOTICE

World Bank Credit Name:

Education Sector Development Project II-Phase 2

1. The Kingdom of Lesotho has received a Credit from the International Development Association (IDA) of the World Bank towards the Cost of Education Sector Development Project and intends to apply part of the funds to cover eligible payments under the contract for the construction of new Government Primary Schools in Lesotho – **P/S-1 (i to v)**. Bidding is open to all bidders from eligible source countries as defined in the Guidelines: Procurement under IBRD loans and IDA credits.
2. The Kingdom of Lesotho which has designated the Principal Secretary, Ministry of Education and Training to undertake this contract, now invites bids for the construction of **Classrooms, Administration Block, Kitchen and Stores, Latrines, Staff Toilets and associated siteworks at the following Primary Schools identified under Lot 1, consisting of five (v) Slices as detailed below:**

A ward of contracts for a slice or for multiple slices is subject to the bidders meeting the cumulative requirements of its technical and financial capacity in terms of Clauses 4.5(a) and (e) of the ITB and the Bidding Data thereto.
