**Fuel and Services Control (Fuel Price Increase) Notice, 2004**

In exercise of the powers conferred on me by section 3(1) of the Fuel and Services Control Act 1983<sup>1</sup>, I,

**MONYANE MOLELEKI**

Minister of Natural Resources, make the following Notice:

**Citation and commencement**

1. This Notice may be cited as the Fuel and Services Control (Fuel Price Increase) Notice, 2004 and shall come into operation on the 9th July, 2004.

**Interpretation**

2. In this Notice, unless the context otherwise requires -

“lowlands” include Quthing, Qacha’s Nek and Mount Moorosi;

“pump price” means the cost price of the fuel reflected on the fuel pump.

**Fuel prices**

3. (1) The fuel prices for Lowlands, Mokhotlong, Mphaki and Thaba-Tseka are as follows:
