And after having read the papers filed of record:

IT IS ORDERED:

1. That the matter is admitted to be heard on an urgent basis.
2. That the respondent be placed under provisional winding up in the hands of the Master of the High Court of Lesotho.
3. That a rule nisi be issued calling upon respondent and all other interested parties to show cause, if any, to this Honourable Court on 27 June 2005 at 09h30 or so soon thereafter as the matter may be heard, why a final order of liquidation should not be granted.
4. That the order be published once in the Public Eye.
5. That the order be served upon the respondent at Distribution Point, Railway Station, Maseru and/or Kingsway Road, Maseru.
6. That BRAIN ST. CLAIR COOPER and DANIEL GERHARDUS ROBERTS be appointed as joint provisional liquidators of the respondent with the power to take over immediate control of respondent's assets and with the further powers set out in Sections 188(1)(a) and (c) and 188(2)(a), (b), (c), (d), (e), (f), (g) and (h) of the Companies Act, 1967.
