GOVERNMENT NOTICE NO. 61 OF 2005

**The Local Government Election Act, 1998 Writ of Election**

**(Section 23 (2))**

**The Returning Officer,**

**WHEREAS** in terms of section 23 (1) of the **Local Government Election Act, 1998** it is provided that for the purposes of every general election of members of Councils, and for the purposes of the election of members to fill vacancies caused by death, resignation or otherwise, the Electoral Commission shall issue writs addressed to the Returning Officer:

**AND WHEREAS** the seats of the elected members for local authority areas or electoral divisions of **Letloepe H0309, Makhaleng A1103, Ratsoleli H0901, Kanana D0905 and Ribaneng A1206 of Letloepe, Makhaleng, Ratsoleli, Kanana and Ribaneng Community Councils** have become vacant in consequence of death;

**NOW THEREFORE** the Independent Electoral Commission, do hereby declare the 10th of December, 2005 as the polling day for by-elections to return members of Community Councils in all the mentioned electoral divisions;

**AND THEREFORE** require that you do on the 1st - 4th November, 2005 nominate candidates in the concerned electoral divisions and that, if necessary, you do cause a poll to be taken on the 10th day of December, 2005.
