## LEGAL NOTICE NO. 72 OF 2006

**Road Traffic (Amendment) Regulations, 2006**

Pursuant to section 14 of the Road Traffic Act 1981, I,

**POPANE LEBESA**

Minister responsible for Public Works and Transport make the following regulations:

**Citation and Commencement**

1. These Regulations may be cited as the Road Traffic (Amendment) Regulations 2006 and shall come into operation on the date of publication in the Gazette.

**First Schedule**
