**Labour Court (Amendment) Rules, 2006**

**Citation and commencement**

1. This Rules may be cited as the Labour Court (Amendment) Rules, 2006 and shall come into operation on the date of their publication in the Gazette.

**Amendment of rule 27**

2. The Labour Court Rules, 1994<sup>1</sup> are amended by adding a new rule after rule 27 as follows:

**“Application for review**

27A. Rules 16 and 17 of the Labour Appeal Court Rules shall *mutatis mutandis* apply to reviews by or before the Labour Court in terms of section 228F of the Labour Code (Amendment) Act, 2000<sup>2</sup>.
