**Members of Parliament Salaries (Amendment of Schedule) (No. 2)  
Regulations, 2006**

In exercise of the powers conferred on me by section 8(b) of the Members of Parliament Salaries Act 1998<sup>1</sup>, and in consultation with the Minister of Finance, I,

**PAKALITHA BETHUEL MOSISILI**

Minister responsible for Parliamentary Affairs, make the following regulations:

**Citation and commencement**

1. These regulations may be cited as the Members of Parliament Salaries (Amendment of Schedule) (No. 2) Regulations, 2006 and shall be deemed to have come into operation on 1st April, 2006.

**Repeal and replacement under Schedule 2**

2. Schedule 2 to the Members of Parliament Salaries Act, 1998<sup>2</sup> is amended:

- “(a) Category B item 6 by deleting ‘M550,000.00’ and substituting ‘M500,000.00’;
- (b) Category C item 4 by adding the words “in respect of Assistant Minister and Deputy Speaker, and M5,000.00 in respect of President of the Senate and Leader of Opposition” after the words “per month”;
- (c) Category C item 9 by deleting “Leader of Opposition” and inserting “Personal Secretary in respect of Leader of Opposition” after Deputy Speaker”;
- (d) Category D item 1 by deleting “M3,000.00” and substituting “M3,500.00”;
- (e) Category D item 4 by deleting “M4,000.00” and substituting

“M4,500.00”;

- (f) Category E item 7 by deleting “M400,000.00” and substituting “M500,000.00”;
- (g) Categories A,B,C, and D by deleting the words “tax-free” before the words “expenses allowances” and “entertainment allowances”.

**Statutory Salaries (Amendment of Schedule) (No. 2) Regulations, 2006**

In exercise of the powers conferred on me by section 6A of the Statutory Salaries Act 1972<sup>1</sup>, I,

**PAKALITHA BETHUEL MOSISILI**

Minister responsible for the Public Service, make the following regulations:

**Citation and commencement**

- 1. These regulations may be cited as the Statutory Salaries (Amendment of Schedule) (No. 2) Regulations, 2006 and shall be deemed to have come into operation on 1st April, 2006.

**Amendment of Schedule 2**

- 2. Schedule 2 to the Statutory Salaries Act, 1972<sup>2</sup> is amended in:
  - (a) Category A by adding the words “Utility car in respect of Chief Justice” after the last item;

- (b) Category B by adding the words-
- (i) “Fully furnished rent-free Government house or housing allowance of M2,500.00 per month in respect of Ombudsman” after the last item;
  - (ii) “**Utilities:** An amount equivalent to 500 electricity units, 15 water units and 800 landline units in respect of Ombudsman” after the last item;
  - (iii) “Responsibility allowance to an amount of M450.00 per month in respect of Ombudsman, M498.00 per month in respect of DPP and M450.00 per month in respect of Auditor-General” after the last item;
  - (iv) “Free utilities in respect of Chairman of I.E.C, P.S.C and T.S.C.” after the last item; and
  - (v) “**Death gratuity:** 4 times annual salary in respect of the Chairman of I.E.C., P.S.C and T.S.C.”.
