In exercise of the powers conferred on me by section 212 (c) of Income Tax Act 1993¹, I,

Minister of Finance and Development Planning make the following Regulations:

Citation and Commencement

1. These Regulations may be cited as the Income Tax (Amendment of Monetary Amounts) Regulations, 2006 and shall be deemed to have come into operation on 1st April 2006.

Interpretation

2. In these regulations, "principal law" means the Income Tax Act, 1993.

Personal Credit

3. The amount "M2,772" in section 73 of the principal law is deleted and substituted by "M2,911".

Tax Bands

4. The amount "M31,500" in the Second Schedule to the principal law is deleted and substituted by "M33,075".

Repeal

5. The income Tax (Amendment of Monetary Amounts) Regulations 2005² are repealed.
