LEGAL NOTICE NO. 83 OF 2022

**National Assembly Electoral Act, 2011¹ Constituency Delimitation
(Amendment) Order, 2022**

Pursuant to section 67(1) and (4) of the Constitution of Lesotho², The Independent Electoral Commission makes the following notice:

Citation and commencement

1. This Order may be cited as the National Assembly Electoral Act, 2011 Constituency Delimitation (Amendment) Order, 2022³ and shall come into operation on the date of publication in the Gazette.

Amendment of Schedule 1

2. Schedule 1 of the National Assembly Electoral Act, 2011 Constituency Delimitation (Amendment) Order, 2022 is amended on -

- (a) Constituency No. 14: Tsikoane, in line 4 from the bottom, by inserting the following words between the words “cross junction.” and “the boundary”;

“It further goes along Mpharane road to cross junction of Maseru, Hlotse, Mapoteng and Maputsoe.”;
- (b) Constituency No. 18: Kolonyama, in line 3 from the bottom, by inserting the word -
 - (i) “between” between the words “goes” and “Morali Crushers Mine”; and
 - (ii) “to” between the words “goes” and “the villages of Ha Mpeke” ; and
- (c) Constituency No. 71: Tsoelike, by deleting
 - (i) the word “leaving” between the words “Matšela-ha-beli” and “Manteko” and substituting the word “taking” in line 3; and

- (ii) the words “into 69” and substituting “into 71”, in line 4;

Declaration of National State of Disaster Notice, 2022

In exercise of the powers conferred on me in terms of sections 3 and 15 of the Disaster Management Act, 1997¹ and acting on the advice of the Board through the Minister in the Prime Minister's Office, I,

MOEKETSI MAJORO

PRIME MINISTER OF LESOTHO, declare a state of disaster throughout the Kingdom of Lesotho caused by floods due to heavy rainfall which threatens the livelihood of the people of Lesotho, and the infrastructure, agricultural production, food security and environment in Lesotho.

2. This declaration shall be for a period of six months with effect from the 17th August, 2022 to the 16th February, 2023.
