**Tourism Levy (Amendment) Regulations, 2022**

In the exercise of the powers conferred on me by Section 18A and 18B of Tourism Act, 2002<sup>1</sup>, I,

**NTLHOI MOTSAMAI**

Minister responsible for tourism, make the following regulations:

**Citation and commencement**

1. These regulations may be cited as the Tourism Levy (Amendment) Regulations, 2022 and shall come into operation on the date of publication in the Gazette.

**Interpretation**

2. In these Regulations, unless the context otherwise requires:

“Regulations” mean “Tourism Levy Regulations, 2021”<sup>2</sup>

**Amendment of Regulation 4**

3. (1) Regulation 4 of the Tourism Levy Regulations, 2021 herein referred to as the principal regulations is amended -

- (a) in paragraph (d), by deleting the words “and” after semi colon;
- (b) in paragraph (e), by deleting “full stop” after the words quarter and substituting “; and”; and
- (c) by inserting the following new paragraph (e) after paragraph (d)  
“(d) subject to these regulations, deal with any other matter related to the Tourism Levy and report to the Board for resolution.”.

**Amendment of Schedule I**

4. Schedule I of the principal regulations is amended -

- (a) by deleting Form C3 and substituting with the following:
