## LEGAL NOTICE NO. 34 OF 2023

**Fuel and Services Control (Oil Levy) Notice, 2023**

Pursuant to section 3(1)(d) of the Fuel and Services Control Act, 1983<sup>1</sup>, I,

**MOHLOMI MOLEKO**

Minister responsible for natural resources, make the following notice:

**Citation and commencement**

1. This Notice may be cited as the Fuel and Services Control (Oil Levy) Notice, 2023 and shall come into operation on the 5th April, 2023.

**Interpretation**

2. In this Notice -

“oil levy” means tax collected from each litre of petrol and sold in the country;

“road maintenance levy” means tax collected from each litre of petrol and diesel sold in the country for the purpose of maintenance of roads within the country; and

“petroleum fund levy” means tax collected from each litre of petrol, diesel, illuminating paraffin, jet fuel, lubricants and oils and liquified petroleum gas per kg sold in the country for the purposes of financing petroleum activities and projects within the Petroleum Sector of the Ministry of Natural Resources.

**Adjustments**

3. The adjustments are as follows:

- (a) oil levy is increased by 10 lisente per litre of petrol and diesel.
- (b) road maintenance levy is increased by 19 lisente per litre

of petrol and diesel.

- (c) Petroleum fund levy is increased by 10 lisente per litre of petrol and diesel, jet A1 fuel and liquified petroleum gas, all products except for illuminating paraffin, lubricants and oils.
