**It is ordered that:**

1. The rules as to notice and form be and are hereby dispensed with on  
account of urgency of this matter.
2. An order is granted in terms of section 88(2) of the Money Laundering  
and Proceeds of Crime Act 4 of 2008 as amended in 2016 (MLPCA) to  
preserve

- 2.1 Plot number unregistered and developed with unroofed buildings situated at Nazareth Ha Rankota, in that all persons with knowledge thereof are prohibited from disposing of, further encumbering, dissipating, attaching or selling in execution, diminishing the value or dealing in any other manner with the said immovable property.
  - 2.2 VW Polo VIN: WVWZZZ9NZ4V007829, Engine: BBY 33401 with registration number A 403 BBC, in that all persons with knowledge thereof are prohibited from disposing of, further encumbering, dissipating, attaching or selling in execution, diminishing the value or dealing in any other manner with the said movable property.
3. The property herein remains under the effective control of Senior Inspector Jobo until the expiration of this order in terms of section 90 of MLPCA or until the conclusion of the forfeiture application.
