**Local Government (Composition of Councils) Notice, 2023**

Pursuant to section 4(1)(d) of Local Government Act, 1997<sup>1</sup>, I,

**LEBONA FABIAN LEPHEMA**

Minister responsible for local government, chieftainship, home affairs and police, determines that a District Council shall consist of not less than 14 but not exceeding 24 members who shall include at least -

- (a) the Chairperson of each Community Council;
- (b) a member of each Community Council elected by the Councilors from amongst themselves; and
- (c) 2 gazetted chiefs, representing all Community Councils in the district, as set out in the Schedule.

**Repeal**

- 2. The Local Government (Composition of Councils) Notice, 2011<sup>2</sup> is repealed.
