**Citation and commencement**

1. This Notice may be cited as the Land Administration Authority (Appointment of members of the Board) Notice, 2024 and shall come into operation on the date of publication in the Gazette.

  - (f) Mr. Nkau Matete - a representative of Bankers' Association;
  - (g) Mr. Taelo Maleka - a representative of Association of Surveyors;
  - (h) Mr. Thuso Green - a representative of Business sector; and
  - (i) Att. Kolisang Mochesane Lepholisa - a representative of Notaries and Conveyancers.

## LEGAL NOTICE NO. 22 OF 2024

**Toll-Gate (Amendment) Regulations, 2024**

Pursuant to section 5 of the Toll-Gates Act, 1976<sup>1</sup>, I,

**RETŠELISITSOE MATLANYANE**

Minister responsible for finance and development planning make the following regulations:

**Citation and commencement**

1. These regulations may be cited as the Toll-Gate (Amendment) Regulations, 2024 and shall come into operation on the 1st day of April, 2024.

**Toll-Gate charge**

2. Regulation 3 of the Toll-Gate Regulations, 2001<sup>2</sup> is amended by deleting subregulation (1) and substituting the following subregulation:

“(1). A vehicle entering Lesotho shall not pass through a toll-gate unless its driver has paid a toll-gate charge of -

- (a) M65.00 for Lesotho registered motorcycles and light vehicles with no heavy axle designed or adopted for conveyance of people or freight;
- (b) M90.00 for foreign registered motorcycle and light vehicles with no heavy axle designed or adopted for conveyance of people or freight;
- (c) M110.00 for Lesotho registered medium heavy vehicles with heavy axle designed or adopted for conveyance of people or freight;
- (d) M150.00 for foreign registered medium heavy vehicles with heavy axle designed or adopted for conveyance of people or freight;

- (e) M160.00 for Lesotho registered large heavy vehicles with 3 axles designed or adopted for conveyance of people or freight;
- (f) M270.00 for foreign registered large heavy vehicles with 3 axles designed or adopted for conveyance of people or freight;
- (g) M390.00 for Lesotho registered extra-large heavy vehicles with 4 or more axles designed or adopted for conveyance of people or freight; and
- (h) M580.00 for foreign extra-large heavy vehicles with 4 or more axles designed or adopted for conveyance of people or freight”.

**Repeal**

3. Toll-Gate (Amendment) Regulations, 2023<sup>3</sup> are repealed.
