In virtue of Section 25 (3) of the Police Act and Section 181 of the Road Traffic Act, traffic arrangements as hereunder will be made on the occasion of the 13<sup>th</sup> China Town Food and Cultural Festival as from **10.00 hrs on Saturday 06.05.2017 to 00.00 hrs on Sunday 07.05.2017** in China Town, Royal Street, Port Louis.

**2. Closed Streets**

- (i) Dr. Sun Yat Sen Street (ex Arsenal Street) - from its junction with Queen Street up to Remy Ollier Street;
- (ii) Royal Street - from its junction with Dr. Joseph Riviere Street up to Dr. Sun Yat Sen Street (ex Arsenal);
- (iii) Dr. Joseph Riviere Street - from its junction with Farquhar Street up to Remy Ollier Street;
- (iv) Emmanuel Anquetil Street - from its junction with Remy Ollier Street up to Queen Street; and

- (v) Dr. Joseph Riviere Street from its junction with Queen Street up to Remy Ollier Street.

**3. Diversion of Traffic**

- (i) Vehicular traffic coming from the South along Royal Street, Port Louis will be diverted onto Louis Pasteur Street via SSR Street or adjoining streets;
- (ii) Vehicular traffic coming from the South along Remy Ollier Street will proceed directly towards the North;
- (iii) Vehicular traffic coming from Plaine Verte along Queen Street will proceed directly to the South; and
- (iv) Buses on routine trips leaving Immigration Bus Stand will either do so via New Trunk Road or use Farquhar Street - Louis Pasteur Street - SSR Street - Sir Edgar Laurent Street - Noor-E-Islam Street and Nicolay Road to proceed to the North.

**4. Parking of Vehicles**

- (i) The Heen Foh Hall parking space and near Heritage Court along Dr. Joseph Riviere Street will be reserved for the parking of VIPs vehicles.

- (ii) Vehicles will be allowed to park at the Lorry Taxi Stand - Immigration Bus Stand - along Farquhar Street and adjoining Streets.

### 5. Prohibited Parking

Vehicles will be prohibited to park along the stretch of Royal Street from its junction with Dr. Joseph Riviere to that with Dr. Sun Yat Sen Street.

### 6. Taxi Stand

The Emmanuel Anquetil Taxi Stand will not be operational and instead will move along Farquhar Street.

### 7. Judicial Proceedings

Non compliance with these traffic arrangements will entail judicial proceeding.
