**NATIONAL DAY CELEBRATIONS 2018  
LAUNCHING CEREMONY**

**Place D'Armes**

By virtue of authority conferred on me under Section 25 (3) of the Police Act and Section 181 of the Road Traffic Act, traffic arrangements as hereunder will be made in Port Louis on **Tuesday 6<sup>th</sup> of March 2018 as from 17.00 hours to 22.00 hours** in connection with above event.

**2. CLOSED ROADS AS FROM 17.00 HOURS**

- (a) Place D'Armes as from its junctions with Motorway up to its junction with Royal Street;
- (b) Intendance Street from its junction with Mallefille Street to that of Chaussee Street; and
- (c) Queen Street from its junction with Bourbon Street to Place D'Armes.

**3. DIVERSION OF TRAFFIC**

- a) Vehicles coming along John Kennedy Street and proceeding towards City Centre via Place D'Armes will be diverted on Dr Ferriere, Chaussee and Poudriere Streets. Vehicles will not be allowed to turn right on Place D'Armes; and
- b) Vehicles coming along Jules Koenig Street and proceeding towards Place D'Armes will be diverted onto F. Mallefille Street.
