2. Each elector will be issued with a ballot paper comprising two sections namely:-

3. Each elector shall vote for fourteen(14) candidates, namely:

by putting a cross(X) opposite the name of each candidate of his /her choice.

4. If an elector votes for more than four (4) or less than four (4) candidates in **each part of SECTION A** and for more than three (3) or less than three (3) candidates in **each part of SECTION B** or places any mark or writing on the ballot paper by which he/she could afterwards be identified, his/her votes will be void and will not be counted.
5. If an elector inadvertently spoils a ballot paper, he/she may return it to the Presiding Officer, who, on being satisfied of the fact, will issue him/her with another one.
6. No elector will be allowed to vote by proxy, except those serving in Rodrigues, Agalega or at Mauritian Embassies or High Commissions abroad.
7. An elector who has appointed a proxy to vote on his/her behalf will not be entitled to vote in person.
