Report on the Financial Statements

I have audited the financial statements of the City Council of Port Louis which comprise the balance sheet as at 31 December 2015 and the income and expenditure account and the statement of cash flows for the year then ended and a summary of significant accounting policies and other explanatory information.

Management's Responsibility for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in Mauritius and in compliance with the Local Government Act and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

Auditor's Responsibility

My responsibility is to express an opinion on these financial statements based on my audit. I conducted my audit in accordance with International Standards of Supreme Audit Institutions. Those Standards require that I comply with ethical requirements and plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial statements. The procedures selected depend on the auditor's judgement, including the assessment of the risks of material misstatement of the financial statements, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to the entity's preparation and fair presentation of the financial statements in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the entity's internal control. An audit also includes evaluating the appropriateness of the accounting principles used and the reasonableness of accounting estimates made by management, as well as evaluating the overall presentation of the financial statements.

I believe that the audit evidence I have obtained is sufficient and appropriate to provide a basis for my qualified audit opinion.

Basis for Qualified Opinion

Capital Outlay - Rs 1,406.7 million

No proper fixed asset register was available. 46 plots of land owned by the Council have not been accounted for. No detailed listing was available for land and buildings of Rs 973.6 million that were acquired prior to 2012. A compactor lorry, worth Rs 3 million, donated by the Parent Ministry in March 2015, was not capitalised. Recurrent expenses of Rs 2.4 million were not charged to the Income Expenditure Account but were wrongly capitalized.

Debtors - Rs 119.8 million

This figure was arrived at after deducting Provision for Bad Debts of Rs 205.2 million from total Gross Debtors of Rs 325 million. Debtors' figure was reduced by an amount of Rs 8.7 million and no Ministerial approval was available. There was no accounting policy, basis of calculation and details for the Provision for Bad Debts.

Gross debtors for General Rate and Trade Fees were Rs 100.6 million and Rs 89.4 million compared to Rs 77.5 million and 133.9 million as per the computerised listing, that is differences of Rs 23.1 million and Rs 44.5 million respectively.

Cash and Bank - Rs 73.8 million

The Cash and Bank Balance as per Balance Sheet of Rs 73.8 million differed from the amount shown in the Notes to the Accounts of Rs 71.8 million.

Creditors and Provisions - Rs 50.5 million

No listings were available for Creditors of Rs 44 million, details of payments of Rs 13 million and Provisions written back of Rs 7.2 million. No provision for refundable sick leaves has been made.

Out of provisions of Rs 34.1 million, some Rs 17.4 million were paid in the subsequent financial semester. Provision has been overstated by some Rs 16.7 million.

Deposits -Rs 5.6 million

No listing of deposits was available.

General Fund - Rs 1,751.8 million

The General Fund Applied Account was credited by a total amount of Rs 13 million for which no corresponding debit entry could be traced.

Passage Fund - Rs 1.6 million

Since 2008, the Passage Fund showed a balance of Rs 1.6 million. The actual passage fund liability and the amount earned by each eligible employee during the year were not determined. Payment for Passage Benefit of Rs 8.9 million was expensed and was not charged to the Fund.

Income-Trade Fees - Rs 84.1 million

Debits raised totaling Rs 100.5 million were reduced by an amount of Rs 16.4 million for which no detail was available.

Investment Income - Rs 1.5 million

Interests received of Rs 21.2 million were credited to the General Fund Unapplied Account and were not recognised in the Income and Expenditure Account.

Income Rentals - Rs 35.6 million

Included in this figure was an amount of Rs 23.5 million representing Market fees receivable for which no detailed list was available.

Qualified Opinion

In my opinion, except for the possible effects of the matters described in the Basis for Qualified Opinion paragraph, the financial statements present fairly, in all material respects, the financial position of the City Council of Port Louis as of 31 December 2015, and of its financial performance and its cash flows for the year then ended in accordance with accounting principles generally accepted in Mauritius.

Other Matter

Accounting Records

The financial reports and cash books were prepared manually although the parent Ministry has invested significantly in the computerised system since 2010. Daily cash collections were uploaded in the system at the year end and not on a daily basis.

Bank balances as per manual cash book and included in the financial statements, were Rs 73.8 million compared to an overdrawn bank balance of Rs 711.2 million in the computerised system. Bank reconciliations were not done using the computerised system. Proper trial balance was not drawn from the computerised system.

Report on Other Legal and Regulatory Requirements

Management's Responsibility

In addition to the responsibility for the preparation and presentation of the financial statements described above, management is also responsible for ensuring that the activities, financial transactions and information reflected in the financial statements are in compliance with the laws and authorities which govern them.

Auditor's Responsibility

In addition to the responsibility to express an opinion on the financial statements described above, my responsibility includes expressing an opinion on whether the activities, financial transactions and information reflected in the financial statements are, in all material respects, in compliance with the laws and authorities which govern them.

I believe that the audit evidence I have obtained is sufficient and appropriate to provide a basis for my opinion.

Opinion on Compliance

Local Government Act

In my opinion, in all material respects, the activities, financial transactions and information reflected in the financial statements are in compliance with the Local Government Act.

Public Procurement Act

The City Council of Port Louis is responsible for the planning and conduct of its procurement. It is also responsible for defining and choosing the appropriate method of procurement and contract type in accordance with the provisions of the Act and relevant Regulations. My responsibility is to report on whether the provisions of Part V of the Act regarding the Bidding Process have been complied with.

In my opinion, the provisions of Part V of the Act have been complied with as far as it appears from my examinations of the relevant records.
