**Traffic Scheme for the Closing Ceremony  
Re - Indian Ocean Island Games 2019  
At Anjalay Coopen Stadium**

By virtue of authority conferred upon me under Section 25 (3) of the Police Act and Section 181 of the Road Traffic Act, traffic arrangement, as

hereunder, will be made on the occasion of the closing ceremony of the Indian Ocean Island Games 2019 at Anjalay Stadium, Belle Vue Harel on 28 July 2019.

**2. Prohibited Parking**

As from 1200 to 2200 hrs no vehicle will be allowed to park or remain stationary along both sides of the undermentioned roads:

- (i) Bois Rouge Road from Pamplemousses Roundabout to Belle Vue Harel Roundabout;
- (ii) Middle Road Mapou from Mapou Roundabout to Belle Vue Harel Roundabout;
- (iii) Middle Road Plaine des Papayes from Belle Vue Harel Roundabout to entrance of Centre Thermique Belle Vue; and
- (iv) Middle Road from Mapou Roundabout to Riviere du Rempart District Council.

### **3. Road closure as from 1430 to 2200 hrs**

Bois Rouge Road, as from Pamplemousses Roundabout on M2 to Belle Vue Harel Roundabout, will be closed to normal vehicular traffic, except for Emerald Card Holders, Residents, IOIG officials, coaches conveying athletes and normal route buses.

### **4. Traffic Diversion**

Normal vehicular traffic will be diverted as follows:

- (i) Vehicular traffic coming from the direction of Plaine des Papayes and proceeding towards Pamplemousses, will on reaching Belle Vue Harel Roundabout use Middle Road towards Mapou Roundabout and Motorway M2; and
- (ii) Vehicular traffic coming from Pamplemousses and proceeding towards Plaine des Papayes will on reaching Pamplemousses Roundabout proceed along Motorway M2 towards Mapou Roundabout, Middle Road and Belle Vue Harel Roundabout.

### **5. Route to Anjalay Stadium for Emerald Card Holders, IOIG Officials and coaches conveying athletes**

- (a) Emerald card holders and IOIG officials proceeding to Anjalay Stadium from the direction of Plaine des Papayes will use Middle Road Plaine des Papayes – Belle Vue Harel Roundabout – Bois Rouge Road to Anjalay Stadium and will park on Anjalay Stadium parking area;

- (b) Emerald card holders proceeding to Anjalay Stadium from the direction of Grand Bay, Piton will use Motorway M2 – Mapou Roundabout – Pamplemousses Roundabout – Bois Rouge Road towards Anjalay Stadium and will park on Anjalay Stadium parking area; and
- (c) Emerald card holders, IOIG Athletes & Officials proceeding to Anjalay Stadium from the direction of Pamplemousses Roundabout will use Bois Rouge Road up to Anjalay Stadium. Cars will be parked on Anjalay Stadium parking area. Coaches after alighting athletes will proceed to the sugar track (ex-Route 22) for parking.

### **6. Route to Anjalay Stadium for Yellow Card Holders and the general public**

Yellow card holders and vehicles of the general public proceeding to Anjalay Stadium from the direction of:

- (i) Grand Bay and Piton will use Motorway M2 – Mapou Roundabout - Middle Rd and park on Anjalay Stadium Public Parking;
- (ii) Plaines de Papayes will use Middle Road – Belle Vue Harel Roundabout – Middle Rd and park on Anjalay Stadium Public Parking; and
- (iii) Pamplemousses and the south will use Motorway M2 – Pamplemousses Roundabout – Mapou Roundabout – Middle Road and park on Anjalay Stadium Public Parking.

7. Drivers shall abide by the directives given by Police officers who will be deployed to regulate traffic and help road users.

8. Notwithstanding above mentioned road closures and Traffic Diversions, Police may for the maintenance of efficient and effective vehicular flow and public safety, amend the traffic arrangements at short notice.

### **9. Judicial Proceedings**

Non-compliance with these traffic arrangements will entail judicial proceedings.

The cooperation and understanding of the public would be much appreciated.

<p><b>Standards for Tour Operator</b></p> <p><b>Standards made by the Tourism Authority under Section 6(f) of the Tourism Authority Act</b></p> <p><b>PART I</b></p>
--

## 1. Background

### 1.1 Definition for tour operator

For the purposes of these standards, a tour operator refers to -

- (a) *“any person who, in respect of tourists and other persons, arranges for, advises on, or undertakes to provide -*
- (i) accommodation;*
  - (ii) destination management services;*
  - (iii) travel arrangements in respect of inland travel;*
  - (iv) organised excursions; or*
  - (v) such other facilities relating to the tourism industry as may be prescribed;*
- (b) *but does not include a person who holds -*
- (i) a taxi licence issued under the Road Traffic Act;*
  - (ii) a pleasure craft licence.”*

1.2 A tour operator shall also include a person who carries out the activities of **tour organiser**, **Destination Management Company**, **outbound tour operator** and **online tour operator** as described hereunder -

- (a) **“tour organiser”** means a person who makes and sells locally-made arrangements for transport, excursions and trips inland or at sea and organises sightseeing on behalf of a Destination Management Company or free independent traveller;
- (b) **“Destination Management Company”** means a person who puts together itineraries comprising accommodation, activities, transportation and guest services that are contracted to international travel companies selling Mauritius as a tourist destination;
- (c) **“outbound tour operator”** means a person who offers travel arrangements or packaged tours or other travel related services to people seeking to travel from Mauritius to foreign destinations;
- (d) **“online tour operator”** means a person who -
- (i) is locally incorporated in Mauritius;
  - (ii) sells, offers and markets travel arrangements including transportation, accommodation, excursions and other related activities online;

- (iii) may market and sell the same services as a Destination Management Company online;
- (iv) subcontracts such services through suppliers or third parties; and
- (v) may collect payment online;

## **2. Scope of Services of a Destination Management Company**

A Destination Management Company shall -

- (a) provide services required for incoming tourists by experienced professionals, including but not limited to -
  - accommodation;
  - assistance at airport on arrival and for departure;
  - transfers from airport to hotels and vice versa in private coaches and cars;
  - makes travel arrangements in respect to inland travel;
  - destination management services for MICE events (meetings, incentives, conferences and events (exhibitions)) and weddings;
  - organisation of sightseeing tours with private coaches and cars and cruises with different kinds of vessels;
  - organisation of any kind of special interest tours;
  - professional and well-trained personnel including hotel representatives, tourist guides, airport staff and drivers;
- (b) enter into contract with international outbound tour operators to act as their representative in the Republic of Mauritius and who is appointed to provide the above services to the clients of such tour operators.

### **3. Place of Business**

3.1 Operators other than online tour operators shall have a place of business where the business transactions are to be executed.

3.2 Except for tour operators already in existence, new tour operators shall provide -

- (a) an area of not less than 15 square meters as office space;
- (b) a reception area with sitting facilities;
- (c) an office with desks, chairs, telephone and Information Communication Technology (ICT) facilities;
- (d) toilet facilities; and
- (e) adequate parking facilities.

3.3 Online Tour Operators

An Online Tour Operator shall have at least -

- (a) professional ICT facilities and equipment;
- (b) a permanent registered address;
- (c) an interactive website; and
- (d) online payment facilities through an accredited online payment system.

### **4. Information to prospective travellers**

4.1 Any package displayed by an operator either at his place of business, website or in any marketing material (including leaflets and brochures) shall indicate inter alia, in a legible, comprehensible and accurate manner the –

- (a) description of product/services on offer; and
- (b) applicable prices at the date of booking.

Prices shall include all taxes and changes with no hidden costs.

4.2 Information to be provided by the operator shall include -

- (a) general information on the destination (climate, time zone, exchange rate, hour of business);
- (b) the attractions to be visited, the different itineraries, meal plan (if any) and the proposed means of transport;
- (c) the type and rating of accommodation, its location, its main features, its meal plan and the accommodation website;
- (d) general information on passport and visa requirements;
- (e) health formalities required for the journey and stay;

- (f) mode of payment: the monetary amount or the percentage of the price which is to be paid upon reservation, and the schedule for payment of the outstanding balance; and
- (g) cancellation policy.

4.3 A receipt (in paper or digital format) shall be issued for each transaction.

## **5. Staffing**

5.1 An operator shall at least have the following minimum personnel -

- (a) a manager with at least 5 years proven experience in a managerial position in the tourism industry (except for a tour organiser);
- (b) one clerical staff with proven experience in the tourism or hotel industry;
- (c) licensed tourist guide(s) if applicable; and
- (d) drivers holding a valid driving licence.

5.2 Staff shall be registered with the Tourism Employees Welfare Fund and for NPS/NPF.

5.3 A licensed operator must ensure that frontline staff are well groomed and can speak the relevant language suitable for the target market.

5.4 Condition 5.1 (i) shall also apply for online tour operator as well.

## **6. Transport facilities**

6.1 The operator shall own or have a contract with one or more service provider(s) for the following -

- (i) a minimum of 3 cars, and
  - (ii) a minimum of 2 coaches
- with Public Service Vehicle Licence.

Copy of contract/MOU (Memorandum of Understanding)/ Letter of intent/copy of PSVL in case the Tour Operator owns the vehicles should be submitted to Tourism Authority at time of application.

6.2 At least 25% of car fleet shall be of either luxury Sedan, SUV or limousine type of 2000 cc for petrol and 2500 cc for diesel or electric or hybrid type. Coaches shall be of luxury type, fully-built, air-conditioned with a minimum seating capacity of 7 passengers and fitted with public address and radio communication system.

6.3 Every vehicle shall -

- (a) not reckon more than five (5) years from the year of manufacture except for luxury Sedan, SUV or limousine type, which shall not be more than seven (7) years from the year of manufacture;
- (b) have the company's name and logo imprinted at the rear and sides of the vehicle;
- (c) be equipped with -
  - an air conditioning system;
  - clean and comfortable seats; and
  - a first-aid kit.

6.4 Drivers must be equipped with a mobile phone or any other communication device, the use of which should be in accordance with law.

6.5 For coaches, the operator shall ensure that a licensed tourist guide is available for sightseeing tours.

6.6 Vehicles carrying persons with disabilities shall at least be equipped with the necessary anchoring equipment, ramps and hoists.

6.7 An operator may subcontract services related to his business only to operators holding valid licences, and satisfying all conditions imposed on the operator.

6.8 The operator shall sign service agreements with subcontractors and carry out audits of vehicles, equipment, licences and insurance policies on a yearly basis.

## **7. Health and Safety**

An operator shall prepare a Safety & Risk Reduction Plan in accordance with international standards.

## **8. Records**

An operator shall -

- (a) keep a record of every transaction in English and in digital format or otherwise which he makes in relation to his business;
- (b) keep yearly record regarding receipts of bookings for a period of not less than 07 years and same shall be made available to officers of the Tourism Authority or statistics Mauritius, upon request;
- (c) ensure that the following details, among others, are specified in the receipt of booking: the company's name, its Business Registration Number (BRN), address of office, email

address, contact number, type and details of service sold, name of client, date and type of transaction, type of currency used, receipt number.

**9. Investment by Non-citizens (Refer to Part II)**

**10. Prohibition**

Only holders of a Tourist Enterprise Licence for Tour Organiser, Destination Management Company, Outbound Tour Operator and Online Tour Operator shall be authorised to carry out activities as defined at paragraph 1.2.

**PART II**

**Criteria for Investment by Non-Citizens  
in Tour Operator**

**1. Local incorporation**

The company shall be locally incorporated.

**2. Experience**

The potential investor shall reckon **at least 5 years experience** in tour operating activities.

**3. Added value**

The potential investor shall bring added value and innovative schemes in the delivery of services.

**4. Letter of Intent**

The potential investor shall produce a copy of letter of intent(s) or contract(s) from international tour operator(s) from the source market(s) where they intend to operate.

**5. Bank Guarantee**

The tour operator shall furnish and maintain a bank guarantee in the sum of **Rs 20 million** in favour of the Tourism Authority.

**6. Sustainability**

The promoter shall demonstrate how the project will benefit the local community.

The above cases have been referred to the Tribunal by the Commission for Conciliation and Mediation under Section 69(7) of the Employment Relations Act (hereinafter referred to as "the Act"). The parties were assisted by Counsel. All the cases were consolidated following a motion made by Counsel for Disputants to which there was no objection on the part of the Respondent. The terms of reference are identical in all the cases, except for the particular names of the disputants and read as follows:

*"Whether I, ..... employed as Computer Data Base Operator holding a Diploma in IT should have been upgraded to Salary Scale 7a instead of Salary Scale 5 with effect from July 2014 or otherwise."*

The Respondent has raised preliminary objections in the present matter and the Tribunal has delivered a ruling setting aside the objections. The Tribunal has proceeded to hear the whole evidence and the submissions of both counsel. Disputant No. 1 deponed on behalf of all the disputants. She stated that all the averments made in her Statement of Case and Statements of Case of the Disputants Nos. 2 and 3 are true. She stressed on the increase in the number of bills that they have to print, that is, from 230,000 in 2002 to 470,000 now and this only for domestic customers. She stated that they are involved in the operation of backup and system server library. She produced a copy of the submission of IT/MIS Department dated 31 July 2013 in relation to the Job Evaluation & Salary Review exercise then undertaken at the Respondent (Doc B).

In cross-examination, Disputant No. 1 conceded that every four years there is a collective bargaining process at the Respondent and there is a salary review where the terms and conditions of employment are reviewed every four years. A new collective agreement is signed every four years. She also agreed that the Disputants were the only officers who were appointed as Computer Database Operator on salary scale 5 on a "Personal to Holder" basis in 2005. In the salary review of 2005, it was mentioned that any new appointment as Computer Database Operator will be on the (lower) salary scale 4. In the salary review of 2009 for the period 2009 to 2013, a new post of IT Technician was created and Disputant No. 1 agreed that the IT Technician has a broader scheme of duties which includes duties they are performing as Computer Database Operators. She however stated that this was "only on paper" as the IT Technician was more often than not on remote sites dealing with computer hardware, troubleshooting and networking issues. She agreed that Disputant No. 2 has retired since the present case was lodged and added that a Trainee IT Technician has come "on and off" in their department. When confronted with the scheme of duties of the Computer Database Operator, she conceded, very reluctantly, that this was the official scheme of duties but averred that this was not in accordance with what they are actually doing. She agreed that despite the collective agreement which was signed, the scheme of duties for Data Base Operators has remained unchanged. She averred that they have not been given due consideration. She however agreed that the IT Technician with a broader scheme of duties than hers is on (lower) salary scale 4 and not on salary scale 5. She deponed in relation to the duties she has to perform as a Computer Data Base Operator, more particularly, in relation to the printing of bills, performing backups

as planned by the IT Manager, inputs pertaining to direct debit operations and assisting the help desk support services.

She agreed that as from 2005 no new Computer Database Operator has been recruited and that instead IT Technicians have been recruited. She made representations to the salary commissioner for the salary review of 2009/2013, made representations in 2013 and again made representations in 2017/2019 but these were turned down. She was referred to the duties and responsibilities of IT posts which were on salary scale 7 and asked if these could fairly be considered as being at the same level as hers. She could not answer and each time stated that she would "leave it for the floor to answer". She however maintained that her duties and responsibilities were those of salary scale 7 even though she admitted that one could not compare the IT posts on salary scale 7 mentioned to her, with her post.

Mr Boodhun, Acting Human Resources Executive at Respondent, then deponed on behalf of the Respondent and he solemnly affirmed to the correctness of the contents of the Statement of Reply of Respondent to the Statement of Case of (each) disputant. He produced a copy of an extract from the Collective Agreement of 2005 whereby Computer Database Operator was put at salary scale 5 on a "Personal to Holder" basis (Doc C). It was also agreed that all new recruits as Computer Database Operator would be on salary scale 4 (Doc D). For the Collective Agreement of 2009, the post of IT Technician was created on salary scale 4 (Doc E) and the said post was again mentioned in 2013 in salary scale 4 (Doc F). Mr Boodhun also produced copies of the scheme of duties for two posts at salary scale 7, that is, the post of Assistant ICT Analyst and that of Assistant IS Analyst (Docs G and G1 respectively). He stated that the Respondent will no longer recruit Computer Database Operators and that the IT Technician will eventually take the post at the Printing Section. He stated that the disputants have been upgraded because of their length of service and in order not to penalise them.

In cross-examination, Mr Boodhun agreed that currently there is no scope for promotion for the disputants but he stated that the disputants can apply for any post in a higher position in another section of the IT Department. He agreed that the posts of Chief Database Operator and Assistant Computer Operator were abolished, though he stated that this was long ago, and that their duties have been shared with the three disputants. He was questioned in relation to other posts bearing in mind the minimum qualifications required for the said posts. He stated that all recommendations made are submitted to the salary consultant and the latter does the job analysis and make his own recommendations. In re-examination, he stated that the posts referred to him require a higher level of responsibility and expertise and cannot be compared with the post *in lite*.

Mr Mohit, Principal Analyst, deponed as a witness for the Respondent and he explained that the Computer Database Operators run computer programs, do backup of IT systems and print bills. He added that they have to open the program, enter the parameters and schedule it for running. He explained the duties the Computer Database Operators have in relation to direct debit and for backup of IT systems. He

confirmed that as per the list of duties, the duties of the IT Technician are broader than the duties of the Computer Database Operator. He stated that the Assistant ICT Analyst and Assistant IS Analyst have more responsibilities than the Computer Database Operator. He stated that when an IT Technician is posted in the Printing Section, he is doing all the duties of a Computer Database Operator. Over and above these duties, the IT Technician may be called upon to perform other duties. Mr Mohit also stated that the duties listed in Annex 11 to Disputants' Statements of Case are in fact duties already contained in their scheme of duties. In cross-examination, he agreed that there is a Trainee IT Technician in the Printing Section. The latter has to go on "site" on very rare cases and on demand.

The Tribunal has examined all the evidence on record including the submissions made by both counsel. Counsel for Disputants, very fairly, conceded in his submissions that he does not deny the finality of the salary consultant report. Right from the stage of the preliminary objections, Counsel for Disputants conceded that there was a collective agreement which was signed. He argued, and rightly so, that a collective agreement applies to the (relevant) bargaining unit and has *préséance* over individual contracts. There was no objection to production of copies of extracts of the collective agreement for the period 2013 – 2017 (Docs A and A1). As per Doc A, the salary review report, subject to the Errors and Omissions Report referred to therein, amongst other documents mentioned, forms part of the Collective Agreement between the parties. The report of the salary consultant (subject to any Errors and Omissions Report) thus forms part of the collective agreement signed between management and the recognised trade union for the bargaining unit which includes the disputants (irrespective of whether they are actually members of that union or not). As per this report, Computer Database Operator (just like IT Technician) was classified at salary scale 4 whereas Computer Database Operator (Personal to Holder) was classified at salary scale 5 (extract produced as Doc F). All this is not disputed before us.

Whilst, section 67 of the Act, upon which Counsel for Respondent has relied in his preliminary objections to move that the disputes be set aside without even hearing evidence, catered strictly for the stage when the matter was at the level of the Commission for Conciliation and Mediation, it is important to bear in mind that the Tribunal, when delivering an award, may have regard to various principles listed under section 97 of the Act. These principles will include, for example, "the principles and best practices of good employment relations". The Tribunal also has to bear in mind relevant international treaties ratified by the Republic of Mauritius to ensure that its award does not go against any such treaties but instead uphold principles enshrined in such instruments. Part III of the Collective Bargaining Convention, 1981 (No. 154) (ratified by Mauritius) relates to the promotion of collective bargaining. Article 5 under the said Part III reads as follows:

*"1. Measures adapted to national conditions shall be taken to promote collective bargaining.*

*2. The aims of the measures referred to in paragraph 1 of this Article shall be the following:*

*(a) ...*

*(d) bodies and procedures for the settlement of labour disputes should be so conceived as to contribute to the promotion of collective bargaining."*

In the present case, there was a collective agreement reached between management and the relevant recognised trade union which related to a salary report drawn by a salary consultant. The present issues were raised with the salary consultant who in his wisdom decided to keep the post of Computer Data Base Operator on grade 5 on a "Personal to Holder" basis. The unchallenged evidence is to the effect that new entrants in the grade of Computer Data Base Operator (if any) would be at grade 4. Also, it has not been challenged before us that the IT Technician has a more comprehensive list of duties than the Computer Data Base Operator, and which may even include the duties performed by the Computer Data Base Operators. Yet, the IT Technician has been graded only at grade 4.

The Tribunal will be failing in its duties if it were to grant the prayers of the disputants in the present matter. Indeed, we are dealing with an organisation where there has been successive collective agreements including the latest one for the period 2013 – 2017 and which agreement "*shall thereafter be deemed to have been renewed by 'tacit reconduction' until a new Collective Agreement in line with the provisions of the Employment Relations Act 2008 – section 55 (3A) is entered into*" (Doc A). The disputants have made representations to the consultant who did not deem it fit to upgrade the post of Computer Data Base Operator to grade 7a or to any other higher grade than grade 5. Based on all the evidence before it, the Tribunal finds absolutely nothing wrong in the grading of Computer Data Base Operator on grade 5 on a "Personal to Holder" basis. New entrants as Computer Data Base Operators, if any, and IT Technicians would, instead, be graded at the lower grade 4. The comparison made in relation to a few other grades which have, allegedly, been upgraded has not impressed us neither since there needs to be a proper job evaluation exercise in terms of duties and responsibilities before one can jump to any conclusions. The simplistic approach of relying excessively on basic qualifications requirements instead of evaluating properly duties and responsibilities attached to the particular posts (after a proper job analysis) has not helped at all to buttress the case of the disputants.

For the reasons given above, the Tribunal finds that, not only there is absolutely nothing on record which would warrant the Tribunal upgrading the disputants to grade 7a (or to any other grade) but there is nothing which shows that they have been unfairly or wrongly treated which would warrant the intervention of the Tribunal. In fact, any conclusion to the contrary in the light of the facts of this particular case would, in our mind, necessarily create anomalies in relation to other grades. Also, any other conclusion in the particular circumstances of this case may affect basic principles of collective bargaining. For all the reasons given above, the disputes are purely and simply set aside.
