**DETERMINATION OF THE PRELIMINARY OBJECTIONS RAISED**

*(Published by the Financial Services Review Panel under section 66(7) of the Financial Services Act)*

1. In their applications lodged on 25 September 2017 with the Financial Services Review Panel (“Review Panel”), the Applicants are seeking a review of the decisions of the Enforcement Committee:
  - (a) revoking the management licence of Applicant No.1; and
  - (b) disqualifying Applicants Nos. 2, 3 and 4 from holding positions as officers in any licensees of the Respondent for a period of 5 years.
2. By letter dated 2 October 2017, the Review Panel requested the Respondent to communicate its stand in the matter within 2 weeks of the date of the letter with copy to the Applicants.
3. The Respondent filed its stand with the Secretary to the Review Panel on 16 October 2017. [In her written submissions dated 07 December 2017, Counsel for the Respondent stated that it filed its stand with the Secretary to the Review Panel on 13 October 2017 and issued copies to the Applicants on 16 October 2017, within the delay given by the Review Panel. The date of 13 October 2017 must be a typing error since according to our record, it was filed on 16 October 2017.]
4. A copy of the stand of the Respondent was, by letter dated 16 October 2017, communicated to the Applicants. According to the Applicants this letter was received by them on 18 October 2017.<sup>1</sup>

- 
5. By letter dated 25 October 2017 addressed to the Review Panel, the Applicants stated that they wished to put on record that –
    - (a) no stand had been submitted by the Enforcement Committee; and
    - (b) the stand of the Respondent was communicated to them outside the delay of 2 weeks.
  6. The Applicants thus –
    - (a) objected to the Review Panel accepting the stand of the Respondent that was communicated outside delay;
    - (b) objected to the Review Panel allowing the Respondent to make (sic) any further stand outside delay;
    - (c) moved that the decisions taken by the Enforcement Committee against the Applicants be cancelled purely and simply; and
    - (d) objected to the Respondent in the circumstances supporting the decisions of the Enforcement Committee against the Applicants and resisting the applications submitted for review.
  7. The case was fixed for hearing on 03 November 2017. Applicant No. 2 tendered a letter from Applicant No. 3 authorising him (Applicant No. 2) and Applicant No.4 to represent Applicant No. 3 in the present proceedings. Counsel for the Respondent took cognizance of the letter and informed the Review Panel that she would consider her stand.
  8. The Review Panel invited submissions on all preliminary issues raised. All submissions, replies and rejoinders were to be filed by 31 January 2018.
  9. According to the Respondent, the application should be set aside since the Applicants have lodged an application for an interim injunction against the Respondent before the Supreme Court (Commercial Division). The Respondent is also contesting the fact that Applicant No. 3 is properly represented before the Review Panel as contended by the Counsel for the Applicants.
  10. To the extent that the Review Panel received the Respondent's stand on 16 October 2017 (within 2 weeks from the letter of the Panel dated 2 October 2017), the objection raised at paragraph 7(a) is a non-starter; and so is the objection at paragraph 7(b).
  11. The objections at paragraphs 7(c) and 7(d) are premised on the fact that the Enforcement Committee is not a party to the present proceedings.
  12. It is here appropriate to refer to the following provisions of the Financial Services Act –

**3.     *Establishment of Commission***

(1) *The Financial Services Commission established under the repealed Financial Services Development Act 2001 shall be deemed to have been established under this Act.*

(2) *The Commission shall be a body corporate.*

(3) ...

#### **4. The Board**

(1) *The Commission shall be administered and managed by a Board.*

(2) ...

(3) ...

(4) ...

#### **7. Powers of Commission**

(1) *The Commission shall have such powers as are necessary to enable it to effectively discharge its functions and may, in particular—*

(a) ...

(b) ...

(c) *with respect to a present or past licensee or any person who is a present or past officer, partner, shareholder, or controller of a licensee—*

(i) *issue a private warning;*

(ii) *issue a public censure;*

(iii) *disqualify a licensee from holding a licence or a licence of a specified kind for a specified period;*

(iv) *in the case of an officer of a licensee, disqualify the officer from a specified office or position in a licensee for a specified period;*

(v) *impose an administrative penalty;*

(vi) *revoke a licence;*

(d) ...

(e) ...

(2) ...

(3) ...

(4) ...

(5) ...

(6) ...

## 52. *Enforcement Committee*

(1) *The Board shall set up an internal committee which shall be known as the Enforcement Committee.*

(2) *The Enforcement Committee shall consist of—*

(a) *2 members to be appointed every year by the Board;*

(b) *not more than 2 employees being of a grade not lower than Executive and not involved in investigations of the licensee under section 44, designated by the Board;*

(c) *such other person having the necessary expertise as may be co-opted by the Enforcement Committee.*

(3) *The Enforcement Committee may exercise the disciplinary powers of the Commission under section 7 (1) (c) to impose an administrative sanction on a licensee.*

(4) *The Enforcement Committee shall have such other functions as may be conferred upon it under the relevant Acts.*

(5) *The members of the Enforcement Committee shall be appointed on such terms and conditions as the Board may determine.*

13. From the above provisions, the Enforcement Committee clearly has no existence or legal personality of its own. It derives its existence from the Commission (here Respondent). This is precisely why section 61(1) of the Financial Services Act provides that where the subject of an application for review (by the Review Panel) is a decision of the Enforcement Committee, the Commission shall be a party to the proceedings. There is therefore no merit in the preliminary objections set out at paragraphs 6(c) and 6(d).<sup>2</sup>

14. The objections raised are accordingly overruled.

15. We now turn to the Respondent's preliminary objections.

16. The Respondent contends that the application should be set aside since the Applicants have lodged an application for an interim injunction against the Respondent before the Supreme Court (Commercial Division). According to the Respondent, the Applicants ought, by virtue of section 54 of the Financial Services

Act, to have applied to the Review Panel for a suspension of the decision of the Committee.

17. The Applicants admit having lodged an application for an injunction before the Supreme Court but for the sole purpose of prohibiting the Respondent from publishing the disqualification and revocation of the licence of Applicants pending the determination of the Review Panel.
18. We agree with Learned Counsel for the Applicants that the application before the Supreme Court for an injunction does not preclude the Review Panel from hearing the present applications.
19. This objection accordingly fails.
20. The second objection raised by the Respondent is that Applicant No.3 is not duly represented before the Review Panel inasmuch as Applicants No.2 and No.4 who signed on behalf of Applicant No.3 did not have a power of attorney authorizing them to represent Applicant No.3.
21. The Respondent relied inter alia on **Group Five International Ltd/Strabag International GmbH Consortium v Independent Review Panel 2014 SCJ 1** where it was held that: "A party to court proceedings may either put in a personal appearance or may be represented by a designated representative. Such representative must be granted a power of attorney duly authorising him to represent the party."
22. Learned Counsel for Applicants referred to section 53 (4) of the Financial Services Act which provides that "Any licensee who is aggrieved by the decision of the Enforcement Committee under subsection (3), (a) may, within 21 days of the issue of the written notification, forward, by registered post, an application to the Review Panel specifying the reasons for a review of the decision; and (b) shall, at the same time, forward a copy of his application by registered post to the Commission." Learned Counsel submitted that the Applicants have fully adhered to the procedure provided and there was no specific requirement or mention that the Application to the Review Panel must be signed by the Applicant or if signed by a third party on behalf of the Applicant it should contain at that stage evidence of authorisation by the Applicant to sign the application on his behalf.
23. Learned Counsel also referred to (i) section 61(3) of the Financial Services Act "Any party to the proceedings before the Review Panel may be represented by counsel or attorney or other representative duly authorised by him who shall be allowed reasonable opportunity to present the case and in particular, to inspect documents which the Review Panel proposes to consider in determining the case" (ii) section 61(4) "The Review Panel shall not be bound by the rules of evidence but may remain guided by them on any matter as it considers appropriate in the circumstances", (iii) under section 62(3) "Subject to the relevant Acts, the Review Panel shall regulate its proceedings as it thinks fit and shall ensure that proceedings

are conducted in a manner which is consistent with the rules of natural justice and procedural fairness."

24. According to the Applicants, under the above provisions, a power of attorney is not required to represent a party to proceedings before the Review Panel. Reference is only made to "authorisation". A copy of the said authorisation with regard to Applicant No.3 was communicated to the Review Panel and to the Respondent. Counsel for the Respondent informed the Review Panel that she would consider her stand regarding the letter.
25. According to Learned Counsel for the Applicants, the letter of authorisation may be accepted by the Review Panel inasmuch as –
- (a) it is not bound by the rules of evidence but remains guided by them on any matter it considers appropriate in the circumstances; and
  - (b) it should regulate its proceedings as it thinks fit and should ensure that proceedings are conducted in a manner which is consistent with the rules of natural justice and procedural fairness.
26. The authority relied upon by Learned Counsel for the Respondent relates to court proceedings. Albeit we have a quasi-judicial jurisdiction, the Review Panel is essentially an administrative body. As an administrative body, we are not governed by the Deposit of Power Attorney Act.
27. We accordingly overrule the second objection raised by the Respondent.
28. Being given that all preliminary objections have been overruled, this matter is to proceed on its merits.
