**THE NURSING COUNCIL ACT 2003**

*[Section 4)(1)(a)]*

**NOTICE OF ELECTION OF TWELVE (12) MEMBERS OF THE NURSING COUNCIL OF MAURITIUS FOR THE PERIOD 2020 – 2023**

Notice is hereby given to all registered nurses and midwives that the election of twelve (12) members of the Nursing Council of Mauritius for the period 2020 – 2023 will be conducted by the Office of the Electoral Commissioner on the nineteenth (19<sup>th</sup>) day of September, 2020; and that the Returning Officer will receive the nomination of candidates for the said election on **Saturday the twenty second (22<sup>nd</sup>) day of August, 2020**, next ensuing, between the hours of **9 a.m. and 12 (noon)** at the seat of the Nursing Council of Mauritius, La Vigie, Forest Side.

The number of members to be elected in the various categories of registered nurses and midwives shall be as follows:

Category	Number of candidates to be elected
(i) General Nursing .....	5
(ii) Psychiatric Nursing .....	1
(iii) Nursing or Midwifery Education .....	1
(iv) Community Health Nursing .....	1
(v) Midwifery .....	1
(vi) Nursing Administration (Nursing Supervisors and above) .....	1
(vii) Nursing Officers from private sector (with working experience in the private sector for at least two years) .....	2

Nomination Papers may be obtained **either** from the Registrar, at the seat of the Nursing Council of Mauritius, at the abovementioned address **or** from the Nursing Administrator, Queen Elizabeth Hospital, Creve Coeur, Rodrigues, between the hours of 9 a.m. and 3 p.m. on working days (excluding Saturdays).

Every Nomination Paper must be signed by **five (5)** registered nurses or midwives from one of the abovementioned categories of nurses and midwives for which the candidate is seeking election, provided that the candidate **belongs to that category by virtue of his/her employment in that capacity**, and be delivered to the Returning Officer between the said hours of 9 a.m. and 12 (noon) on 22 August 2020.

Every Nomination Paper shall specify the names, address and date of registration of the candidate and also contain a declaration by the candidate that:-

- (a) on nomination day he/she is a registered nurse or midwife and is not otherwise suspended;
- (b) on nomination day he/she reckons at least 10 years' experience as a nurse or a midwife in Mauritius;
- (c) he/she will not retire from office prior to polling day;
- (d) he/she is a citizen of, and resident in, Mauritius; and
- (e) he/she belongs to the category in which he/she is seeking election by virtue of his/her employment in that capacity.

Upon delivery of his/her Nomination Paper to the Returning Officer, each candidate is also requested to produce his/her **certificate of registration and his/her letter of appointment from the employer**.

In the case of a nursing officer from the private sector, he/she should also produce a **certificate from the employer to the effect that he/she has been employed in the private sector for at least 2 years.**

Nomination papers received by post, fax, email or otherwise will not be considered. Nomination papers duly filled in by prospective candidates in Rodrigues shall be deposited at the Sub Office of the Electoral Commissioner, Port Mathurin, on the aforementioned date and time.
