**NOTICE UNDER SECTION 4(1) OF THE QUARANTINE ACT 2020**

WHEREAS section 4(1) of the Quarantine Act 2020 provides that where the Minister considers that it is necessary and expedient to prevent the introduction and spread in Mauritius of a communicable disease, he shall, by notice published in the Gazette, declare that –

- (a) there is or is likely to be an epidemic of the disease; and
- (b) a quarantine period shall be in force in Mauritius, or part thereof, as from such date as may be specified in the notice.

2. WHEREAS I was satisfied that it was necessary and expedient to prevent the introduction and spread of COVID-19 in Mauritius, I ordered, by virtue of General Notice No. 1545 of 2020 –

- (a) that there was still an epidemic of COVID-19; and
- (b) the extension of the quarantine period in Mauritius from 31 October 2020 to 30 November 2020.

3. NOW, THEREFORE, in view of the fact that I am still satisfied that it is necessary and expedient to prevent the introduction and spread of COVID-19 in Mauritius, I do hereby –

- (a) declare that there is still an epidemic of COVID-19; and
- (b) extend the quarantine period in Mauritius from 30 November 2020 to 15 January 2021.
