#### Notice of Passport Fees in respect of Passport Services offered at Malawi Foreign Missions

It is published for the information of the general public that Honourable AARON SANGALA, Minister of Internal Affairs and Public Security, has approved new fees in respect of Malawian passports processed at Malawi foreign missions as follows—

1. Ordinary passport—		
(a) on the normal issuance of an ordinary passport . . . . .	10 years	US\$200
(b) for replacement of renewal of an ordinary passport . . . . .	10 years	US\$200

2. Passport for children aged 10 years and below—		
(a) on the normal issuance of an ordinary passport . . . . .	5 years	US\$150
(b) for replacement of renewal of an ordinary passport . . . . .	5 years	US\$150
(c) for replacement of an ordinary passport as a result of loss or theft . . . . .	5 years	US\$175
3. Non-refundable processing fee on each passport application . . . . .		US\$25
4. Emergency Certificates . . . . .		US\$50
