Introduction of New Series of Bank Notes and Coins Malawi Kwacha

In accordance with section 20 of the Reserve Bank of Malawi Act, I, CHARLES SYDNEY R. CHUKA, Governor of Reserve Bank of Malawi, hereby give notice that the Reserve Bank of Malawi shall introduce new series of K20, K50, K100, K200, K500 banknotes and for the first time, a K1,000 banknote and a new series of K1, K5 and K10 coins with effect from 23rd May, 2012.

The new banknotes series shall run side by side with the old series for a period of one year from 23rd May, 2012, after which the old series shall be withdrawn and cease to be legal tender. The above notwithstanding, the old K1, K5 and K10 coins will circulate simultaneously with the new coins until such a time as the Reserve Bank of Malawi announces their withdrawal from circulation.
