Call for Public Representations on the Proposed Amendment to the Individual Licence to Provide Public Telecommunication Services in the Republic of Malawi Awarded to—

CELTEL MALAWI (TRADING AS AIRTEL MALAWI LIMITED)

The Malawi Communications Regulatory Authority (MACRA) would like to inform the general public that it intends to amend clause 20 of the Public Telecommunications Services License that it awarded to CELTEL Malawi Limited to read as follows—

Clause 20: Licence Fees

Clause 20 (c) of the Licence is hereby amended to read as follows—

“A levy equal to five (5%) per cent of the Net Operating Revenue for each year payable at the end of each quarter in four (4) equal quarterly instalments. Calculation of the first three (3) quarterly instalments shall be based upon the management accounts for that particular period. A final quarterly payment shall be made based on Net Operating Revenue within thirty (30) days of issue of the audited accounts. Adjustments shall be made for the first three (3) quarterly payments if the Net Operating Revenue in the management accounts differs from the one in the audited accounts.”

Pursuant to Section 23 of the Communications Act, Cap. 68.01 of the Laws of Malawi, MACRA would like to call the general public to make representations on the proposed amendments.
