(b) In excess of 10 kilolitre water: for every kilolitre supplied, or part thereof, per month or part of a month R0,65

(c) Miscellaneous charges:

The tariffs due and payable for -

- (a) replacing a seal which has been tampered or interfered with by the consumer;
- (b) disconnecting or connecting the water supply at the request of the consumer;
- (c) reconnection after supply has been cut off for breach of these regulations;
- (d) connection fees for all new connections;
- (e) fees payable for any tests made or other work performed at the request of the consumer shall be equivalent to the cost thereof to the Council; and
- (f) rent for a water-meter per month,

shall be those contained in items 2 to 7 of Schedule B to the Council's Water Supply Regulations promulgated under Government Notice 66 of 1960, as amended."
