**ELECTORAL ACT, 1992: BY-ELECTION FOR CAPRIVI
REGION REGIONAL COUNCIL: KABE CONSTITUENCY:
DETERMINATION OF DAYS AND PLACES FOR
SUBMISSION OF NOMINATIONS OF CANDIDATES
AND POLLING DAYS**

Under the powers vested in me by subsection (1) of section 50 of the Electoral Act, 1992 (Act 24 of 1992), I hereby make known -

(a) that I have under paragraph (a) of that subsection determined -

- (i) Wednesday, 26 May 1993, as the day on which a public sitting shall be held in the Kabe Constituency in the Caprivi Region for the submission of nominations of candidates for election of a member of the Regional Council for that Region;

- (ii) that the said public sitting shall be held at Kabe Secondary School from 09:00 until 11:00 on that day;
- (b) that I have under paragraph (b) of that subsection determined that if a poll becomes necessary in the said constituency for the reason that more than one person shall have been duly nominated at the close of the said sitting, the poll shall be taken on 23 June 1993 and 24 June 1993 and which shall commence at 07:00 and close at 21:00 on both those days.
- (c) in terms of paragraph (c) of that subsection, that Mr. D. Smith of the Office of the President has been appointed in terms of section 51 of the said Act as returning officer at the election in the said Constituency.
