AMENDMENT OF SEA FISHERIES REGULATIONS

The Minister of Fisheries and Marine Resources has under section 32 of the Sea Fisheries Act, 1992 (Act 29 of 1992), made the regulations set out in the Schedule :-

SCHEDULE

1. In this Schedule "the Regulations" means the Sea Fisheries Regulations, promulgated by Government Notice 1 of 1993, as amended by Government Notices 2 of 10 January 1994, 204 of 1 November 1994, 88 of 1 June 1995, 153 of 15 September 1995, 26 of 1 February 1996, 14 of 15 February 1997 and 64 of 15 April 1997.
2. The Regulations are hereby amended by the substitution of the following annexure for Annexure Q :-

It is hereby made known -

- (a) in terms of section 22(2) of the Roads Ordinance, 1972 (Ordinance 17 of 1972), that the Minister has, in the districts of Keetmanshoop and Karasburg -
 - (i) under section 22(1)(a) of the said Ordinance declared the portion of the road described in Schedule I and shown on sketch-map P1597 by the symbols C-D to be a proclaimed road; and
 - (ii) under section 22(1)(c) of the said Ordinance closed a portion of district road 566 described in Schedule II and shown on sketch-map P1597 by the symbols C-C1-C2-C3-E.
- (b) in terms of section 23(3) of the said Ordinance that the Minister has -
 - (i) under section 23(1)(c) of the said Ordinance declared the portion of the road referred to in paragraph a(i) to be a district road (number 566);

- (ii) under section 23(1)(e) of the said Ordinance, the declaration of farm road 566 described in Schedule III and shown on sketch-map P1597 by the symbols A-B-C be amended to district road 566.

**VARIATION OF CONDITIONS OF ESTABLISHMENT:
PLAATJIES HEUWEL (EXTENSION 1)**

In terms of paragraph (b) of the proviso to section 31A(2) of the Townships and Division of Land Ordinance, 1963 (Ordinance 11 of 1963), I hereby make known that I have under the said section 31A(2) of the said Ordinance varied the conditions contained in the Schedule to Government Notice No. 133 of 1993, by the substitution for item 3 of the following item:

"3. CONDITIONS OF TITLE

- (1) The following conditions shall be registered in favour of the local authority against the title deeds of all erven:
 - (a) The owner or occupier of an erf shall permit -
 - (i) water pipelines, storm-water drain-pipes, sewer-pipes or overhead or underground electrical supply-lines, as may from time be considered necessary by the local authority, to be constructed across the erf in such a manner and in such a position as may from time to time be determined by the local authority after consultation with the owner of the erf;

- (ii) any material that may be excavated during the construction, maintenance or removal of any water-pipeline, storm-water drain-pipe, sewer-pipe or overhead or underground electrical supply-line, to be placed on the erf temporarily;
- (iii) any material that may be excavated during the construction, maintenance or removal of any water-pipeline, storm-water drain-pipe, sewer-pipe or overhead or underground electrical supply-line, on any adjoining property to be placed on the erf temporarily;
- (iv) any person who may be required to enter the erf in order to perform his or her duties pertaining to the construction, maintenance or removal of any such water-pipeline, storm-water drain-pipe, sewer-pipe or overhead or underground electrical supply-line or any other work pertaining thereto, to enter the erf at all reasonable times.

without any compensation being recoverable from the local authority: Provided that any damage caused during the construction, maintenance or removal of any such water-pipeline, storm-water drain-pipe, sewer-pipe or overhead or underground electrical supply-line or any other work pertaining thereto or any damage caused through the placing on or removal from the erf of any material referred to in subparagraph (ii) or (iii) shall be compensated by the local authority.

- (b)
 - (i) The owner of an erf shall, at his or her own expense, erect a retaining wall or retaining walls approved by the local authority, to prevent any portion of the erf from falling into any street adjoining the erf, or *vice versa*.
 - (ii) Where the owner of the erf has already erected a retaining wall or walls approved by the local authority, and any street or streets adjoining the erf are thereafter constructed or reconstructed on such a level that, as a consequence thereof, a new retaining wall or walls are required to be erected or an existing retaining wall or walls are required to be altered to prevent any portion of the erf from falling into the street or *vice versa*, such erection or alteration, as the case may be, shall be effected at the expense of the local authority.
- (2) The following conditions shall, in addition to those enumerated in paragraph (1), be registered in favour of the local authority against the title deeds of erven 107 to 149 and 151 to 160:
 - (a) The erf shall be used for residential purposes only.
 - (b) Only one building designed and destined for occupation by only one family, with the necessary outbuildings, may be erected on the erf.

(3) The following conditions shall, in addition to those enumerated in paragraph (1), be registered in favour of the local authority against the title deed of erf 150:

- (a) The erf shall be used for religious purposes only.
- (b) Only a church and parsonage shall be erected on the erf.
- (c) The building value of the church and parsonage shall be at least N\$40 000,00."
