**AVIATION ACT, 1962:  
AMENDMENT OF THE STATE AIRPORT  
REGULATIONS, 1963**

The Minister of Works, Transport and Communication has under section 22 of the Aviation Act, 1962 (Act 74 of 1962), made the regulations set out in the Schedule.

## SCHEDULE

1. In these regulations "the Regulations" means the State Airport Regulations promulgated by Government Notice R.1974 of 20 December 1963, as amended by Government Notices R.397 of 20 March 1964, R.2027 of 24 December 1965, R.943 of 23 June 1967, R.1031 of 26 June 1970, R.2233 of 11 December 1970, R.331 of 9 March 1973, R.1258 of 27 July 1973, R.1564 of 31 August 1973, R.1677 of 14 September 1973, R.2443 of 21 December 1973, R.774 of 18 April 1975, R.142 of 30 January 1976, R.1472 of 20 August 1976, R.2512 of 24 December 1976, R.2633 of 30 December 1977, R.441 of 10 March 1978, No. 223 of 1 December 1995 and No. 61 of 1 April 1998.

2. The following Paragraph is hereby substituted for Paragraph E.3 of Annex E of the Regulations:

"Paragraph E.3

### E.3 PASSENGER SERVICE CHARGES

The following passenger service charges are payable by an aircraft operator engaged in commercial air transport operations. Payment is to be made within 30 days of having received an invoice in such regard:

Per departing passenger where the passenger will disembark from the aircraft at an aerodrome within Namibia .....	20.00
Per departing passenger where the passenger will disembark from the aircraft at an aerodrome outside Namibia but within the SADC region .....	40.00
Per departing passenger where the passenger will disembark from the aircraft at an aerodrome in State other than those mentioned above .....	60.00

(Passenger service charges are not applicable to passengers in transit for less than 6 hours, passengers who have not yet reached their second birthday and flight and cabin crew members travelling in the course of duty)."

This regulation shall come into operation on 1 November 1998.

**CLOSING OF FARM ROAD 603: DISTRICT OF KEETMANSHOOP:  
KARAS REGION**

In terms of section 22(2) of the Roads Ordinance, 1972 (Ordinance 17 of 1972), it is hereby made known that the Minister has under section 22(1)(c) of the said Ordinance, in the district of Keetmanshoop, closed farm road 603 described in the Schedule and shown on sketch-map P2025 by the symbols A-B-C.

The said sketch-map shall at all times lie open to inspection at the office of the Permanent Secretary: Works, Transport and Communication, Windhoek, during normal office hours.
