**SEA FISHERIES ACT, 1992: DETERMINATION OF TOTAL
 ALLOWABLE CATCH IN RESPECT OF ROCK LOBSTER**

Under section 15 of the Sea Fisheries Act, 1992 (Act No. 29 of 1992), and after consultation with the Sea Fishery Advisory Council, I hereby determine that the Total Allowable Catch in respect of rock lobster for the allocation of quotas during the 1998/99 rock lobster season commencing on 1 November 1998 and ending on 30 April 1999, shall be 300 metric tons, which shall, in relation to each area mentioned in the first column of the table set out below, for the purpose of allocating quotas in respect of the period specified opposite such area in the second column of that table, be apportioned as specified opposite such area in the third column of that table:

- "(2) The following conditions shall in addition to those enumerated in paragraph (1), be registered in favour of the Town Council of Khorixas against the title deeds of erven 3041 to 3158, 3160 to 3175, 3177 to 3381 and 3385:
- (a) The erf shall be used for residential purposes only.
 - (b) The building value of a dwelling unit, including the outbuildings, to be erected on the erf shall be at least two times the prevailing valuation of the erf by the Town Council of Khorixas.
