Under the powers vested in me by section 3(4A) of the Local Authorities Act, 1992 (Act No. 23 of 1992), I determine 17 December 2005 as the date on which the election of members of -

- (a) the town council of Okahao;
- (b) the village council of Oshikuku; and
- (c) the village council of Ruacana,

shall be held.

**ELECTION FOR OKAHAO, OSHIKUKU AND RUACANA LOCAL  
AUTHORITY COUNCILS: DETERMINATION OF DAYS FOR SUBMISSION  
OF NOMINATIONS OF CANDIDATES AND POLLING DAYS FOR ELECTIONS**

Under the powers vested in me by subsection (1) of section 50 of the Electoral Act, 1992 (Act No. 24 of 1992), I hereby make known that -

- (a) I have under that subsection determined -
- (i) Wednesday, 16 November 2005, as the last day on which political parties that intend to take part in the election for members of the Okahao, Oshikuku or Ruacana local authority council shall, not later than 11h00 on that day, in terms of section 68 of the Electoral Act, 1992, submit a list of their nominated candidates;
  - (ii) that the said list of candidates shall be submitted in respect of -
    - (aa) the local authority area of Okahao, at the Regional Council Hall, Okahao;
    - (bb) the local authority area of Oshikuku, at the ELCIN Church, Oshikuku;
    - (cc) the local authority area of Ruacana, at the Ombuumbuu Junior Secondary School, Ruacana;
  - (iii) Saturday, 17 December 2005, as the day on which a poll shall be taken at any election referred to in subparagraph (i);
- (b) the following persons have in respect of the local authority elections referred to in paragraph (a)(i) been appointed in terms of section 51 of the Electoral Act, 1992, as returning officers for -
- (i) the local authority area of Okahao, Immanuel Kanjeketela;
  - (ii) the local authority area of Oshikuku, Gofulga Marius Sheeya;
  - (iii) the local authority area of Ruacana, Joseph Ausiku.
