**5. DETAILED REASONS WHY SUCH ALTERATION, MODIFICATION OR AMENDMENT IS SOUGHT:**

5.1 Applicant currently conducts scheduled flights from Eros Airport to Tsumeb and Scorpion mine and Oranjemund, as well as Eros and Johannesburg International Airport. Currently five frequencies per week are offered between Eros and Rosh Pinah/Scorpion.

5.2 Applicant was requested by Rennie's Travel to urgently consider revising its scheduled departure and arrival times to and from Eros and Rosh Pinah as well

as possibly providing more frequencies on this route.

5.3 Subsequent to discussions with management of Scorpion Mine, Kumba Sinc Mines, De Beers Marine and Rennie's Travel it was concluded that a demand exists with these clients of the applicant to include Hosea Kutako on its itinerary on certain weekdays.

5.4 As four passengers (half of average) will not be economically viable this option can only be viably offered if combined with the Eros/Scorpion schedule to redirect it via Hosea Kutako.
