**AMENDMENT OF ENTRY FEES PAYABLE IN RESPECT OF FOREIGN
VEHICLES AND REGISTRATION AND ANNUAL LICENSE FEE AND MASS
DISTANCE CHARGE AS CONTEMPLATED IN SECTION 18 (1)(b)(c): ROAD
FUND ADMINISTRATION ACT, 1999 (ACT NO. 18 OF 1999)**

Under section 18(1)(a)(b)(c) of the Road Fund Administration Act, 1999 (Act No. 18 of 1999), the Road Fund Administration hereby amends, with effect from 1 April 2009, Government Gazette No. 3816 of 30 March 2007, on every foreign vehicle that temporarily enters Namibia, by the substitution of the Annexure A thereto with the Annexure A specified below, and registration and license fees in respect of motor vehicles registered in Namibia, by the substitution of the Annexure B thereto with the Annexure B specified below, also Mass distance charge for all vehicles above 3,500kg driven on Namibia roads, by the substitution of the Annexure C thereto with Annexure C specified below.
