THE MINISTRY OF WORKS AND TRANSPORT (GOVERNMENT GARAGE) HEREBY INVITES COMPANIES/BIDDERS FOR EXPRESSION OF INTEREST IN DEVELOPING, SUPPLY AND MANAGEMENT OF E-FUEL FOR GOVERNMENT VEHICLE FLEET FOR THE PERIOD OF TEN YEARS.

GOVERNMENT VEHICLE AND PLANT DATA

THE GOVERNMENT GARAGE CURRENTLY OPERATES A FLEET OF APPROXIMATELY 3000 VEHICLES AND PLANT ITEMS OF SMALL MOBILE. MOST OF THE ITEMS ARE FITTED WITH ODOMETERS, HOUR METERS AND OR FUEL ON-ROAD. THERE ARE ALSO VARIOUS GOVERNMENT MINISTRIES OWNING THEIR OWN FLEET OF VEHICLES AND FIXED PLANT THAT MAY ALSO MAKE USE OF THE SERVICES REQUESTED.

FUELLING SYSTEM

OBJECTIVES OF THE GOVERNMENT GARAGE REGARDING THE EXPRESSION OF INTEREST

THE MINISTRY OF WORKS AND TRANSPORT (GOVERNMENT GARAGE) INVITES SUBMISSION OF INTERESTED COMPANIES/BIDDERS TO DEVELOP, SUPPLY AND MANAGE FUEL MANAGEMENT SYSTEM FOR GOVERNMENT VEHICLES AND PLANTS. THE COMPANIES/BIDDERS PROPOSAL FOR THE MANAGEMENT OF GOVERNMENT GARAGE HOME BASE FILLING STATIONS ON A LEASING BASE, IN-HOUSE MOBILE TANKERS, JERRY CANS AND ON-ROAD FUELLING AT COMMERCIAL FUEL STATIONS SHOULD BE AVAILABLE FOR 24 HOURS FOR THE DURATION OF THE CONTRACT.
