5. GENERAL

In the event of incorrect billing, customers are entitled to register a dispute over the affected portion of the account by reporting through the Customer Care Centre's toll free number 1100 or the nearest Teleshop of Telecom Namibia Limited.

Reasons for the Authority's Decision

Telecom Namibia Limited (hereinafter referred to as "Telecom Namibia") filed for the approval of tariffs for Voice Call Plans/Packages on 13 December 2013, in terms of section 53 (1) and (7) of the Communications Act No. 8 of 2009 (hereinafter referred to as "the Act").

The proposed tariffs were published as General Notice No. 42 in the Government Gazette No. 5411 dated 17 February 2014 in terms of Regulation 8 of the "Regulations Regarding the Submission of Interconnection Agreements and Tariffs" published in Government Gazette No. 4714 of 18 May 2011.

Comments were invited from the public, in terms of the Notice published in the Government *Gazette*, within a period of fourteen (14) days from the date of publication of the Notice in the Government *Gazette*, which period lapsed on 3 March 2014. No public comments were received in respect of the tariffs as published during the commenting period, and as such no reply comments were required from Telecom Namibia.

A comparison of the proposed tariffs was done against the current tariffs. Overall, the new proposed tariffs are lower than the currently charged tariffs.

The tariffs as submitted for Talk International are lower than the currently charged tariffs. The Multi-Talk Family Package which allows family members in the same or different towns to apply for more than one analogue exchange connection for different family members under one name. This brings along some savings on call rates between these numbers, rental and installation.

The Corporate Call Plans will enable customers to make local and national calls at special rates after reaching a pre-defined usage threshold in minutes or customers will pay a monthly flat fee and will enjoy unlimited local and national call minutes.

The Least Cost Routing (LCR)/Private Branch Exchange (PABX) Solution Package offers a combination of fixed and mobile service. The above packages offer value for money by either offering lower tariffs or more services to the customer. The tariffs are deemed reasonable and do not impair competition.

All requirements in terms of section 53 of the Act that deals with the approval of tariffs have been adhered to. The tariffs were published in the Government *Gazette* as required in terms of section 53(10) of the Act for comment and Telecom Namibia stated that the tariff would come into force on 11 February 2013 in terms of section 53(8) of the Act. All pertinent information as required by section 53(9) was submitted to the Authority such as the terms and conditions in terms of the tariffs. The tariffs were accompanied by such accounting and cost information as required by section 53 (18). Based on the analysis and reasons advanced above, the Authority approved the proposed tariffs for Voice Call Plans / Packages submitted by Telecom Namibia Limited.

REASONS FOR APPROVAL OF TARIFFS

Paratus Telecommunications (Pty) Ltd (hereinafter referred to as "Paratus Telecommunications") filed for the approval of tariffs for National Standard 4G Broadband (WIMAX) Bundles and voice services on 8 November 2013 in terms of section 53 (1) and (7) of the Communications Act No. 8 of 2009 (hereinafter referred to as "the Act"). The submission was made to implement the new pricing as promotional pricing in terms of section 53(2) of the Act and obtain approval in terms of section 53 (1) and (7) to implement tariffs of data (WiMax) and voice services going forward pending a final decision by the Board of Directors of the Authority.

The proposed tariffs were published as General Notice No. 513 in the Government Gazette No. 5369 dated 20 December 2013 in terms of Regulation 8 of the "Regulations Regarding the Submission of Interconnection Agreements and Tariffs" published in Government Gazette No. 4714 of 18 May 2011.

Comments were invited from the public, in terms of the Notice published in the Government Gazette, within a period of fourteen (14) days from the date of publication of the Notice in the Government Gazette, which period lapsed on 6 January 2014. No public comments were received in respect of the tariffs as published during the commenting period, and as such no reply comments were required from Paratus Telecommunications.

All requirements in terms of section 53 of the Act that deals with the approval of tariffs have been adhered to. The tariffs were published as stipulated in section 53(10) for comment and Paratus Telecommunications stated that the tariff would come into force on 4 November 2013 as required by section 53(8) of the Act. All pertinent information as required by section 53(9) was submitted to the Authority such as the terms and conditions. The tariffs contained all pertinent information relating to the tariff such as costing and budget information as required by section 53(18) of the Act.

It is difficult to compare and benchmark the data packages due to the differences in the packages offered by the market players. The upload and download speed differs, the amount of data offered differs and the overall packages differ. The package offered by Paratus Telecommunications will however offer customers a new product, which in turn will provide more choice and competition. The tariffs are further deemed reasonable and promote competition.

The tariffs are deemed reasonable and do not impair competition. These tariffs compare very well with the Telecom Namibia Limited fixed line tariffs and should provide healthy competition tariffs and an incentive to the incumbent to reduce tariffs in the future. It is also not deemed to be unreasonably discriminatory by the Authority in terms of section 53(19) of the Act since the tariffs submitted are competitive compared to the other operators in the market.

The licence is issued subject to the Communications Act, 2009 (Act No. 8 of 2009) and the Regulations Regarding Setting Out Conditions for Spectrum Use Licences, as published in Government Gazette No. 5354, Notice No. 469, dated 02 December 2013.

The following are the reasons for the decision:

Following due process in terms of Regulations Regarding Licensing Procedures for Telecommunications and Broadcasting Service Licences and Spectrum Use Licences the Authority published a notice in the Government Gazette 5343, Notice No 434, dated 14 November 2013 allowing fourteen (14) days for public comments as required by section 9(3) of the aforementioned regulations. No comments were received within the aforementioned period for comments.

Namibia is bound by the Cabinet's Decision #4/12.03.02/010 to allow CTBTO to operate VSAT equipment located in Windhoek and Tsumeb to conduct monitoring of nuclear explosions. Operation of a private ECNS network does not require the issuance of a telecommunications service licence in terms of Regulation 5(2) of the Regulations Setting out Broadcasting and Telecommunications Service Licences as published in Government Gazette No. 4714, Notice No. 124 dated 29 August 2011 (as amended).

Therefore, the Authority concluded to only consider the application for spectrum use licenses. Section 101(6) requires the issuance of a spectrum use licence to an applicant, should the offering of envisaged service requires spectrum in the appropriate spectrum band for Fixed Satellite (Earth-to-Space). The application also complies with all the substantive requirements as captioned in regulation 6 of the Regulations Regarding Licensing Procedures for Telecommunications and Broadcasting Service Licences and Spectrum Use Licences.

The licence is issued subject to the Communications Act, 2009 (Act No. 8 of 2009) and the Regulations Regarding Licence Conditions for Telecommunications Service Licences, as published in Government Gazette No. 5037, Notice No. 308, dated 13 September 2012. The following are the reasons for the decision:

Telepassport Communications (Pty) Ltd (hereinafter referred to as the "licensee") has been providing voice arid SMS services to corporate customers via least cost routing since, utilizing the number ranges and cellular networks of Mobile Telecommunications Limited and Powercom (Pty) Ltd (now owned by Telecom Namibia Limited.) since 2004. Telepassport Communications (Pty) Ltd maintains its own billing and customer administration systems and is also responsible for implementation of customer end-user equipment and networks.

Pursuant to the provisions of section 135(5) of the Act, the licensee was, therefore, lawfully providing telecommunications services without a licence on date of commencement of the Act. This is because the Namibian Communications Commission Act (4 of 1992) now repealed, did not require a licence

for the provision of the services that were provided by licensee. However, the Communications Act (No 8 of 2009) (Hereinafter referred to as the "Act") now requires such services to be licenced. Licensee was therefore, requested to submit an information form in terms of section 135(5) of the Act. The licensee complies with the provisions of section 46(1) of the Act, in that it is a company incorporated in Namibia and Namibian citizens own 60% of its shareholding.

Licensee did not submit an application for spectrum use because it does not own or maintain an electronic communications network. Proof of the least cost routing agreements with Mobile Telecommunications Networks and Powercom (Pty) Ltd t/a Leo were submitted to the Authority.

The fact that Telepassport Communications (Pty) Ltd has been operating since 2004 on a sustainable basis as illustrated by its annual financial report indicates that the market can support licensees providing telecommunications services to specific market segments whilst acquiring network access from exiting Class Comprehensive (ECS & ECNS) service licence holders.

REASONS FOR DECISION

The reasons for the above-captioned decision are as follows:

1. The withdrawal and transfer applications comply with the substantive and procedural requirements set out in the Communications Act and the Regulations Regarding Licensing Procedures for Telecommunications and Broadcasting Service Licences and Spectrum Use Licences.

- 2. The applicant has cited the reasons for the withdrawal and transfers respectively, which is that Telecom Namibia Limited has acquired 100% shareholding of Powercom (Pty) Ltd t/a Leo and wishes to integrate the GSM business into its operations. Powercom (Pty) Ltd t/a Leo, will therefore, permanently discontinue providing licensed services in terms of its previously held licence, as awarded on 16 April 2012, published in Government Gazette 4930, Notice No. 106.
- 3. As per the applications submitted, Powercom (Pty) Ltd t/a Leo will now be integrated into the Telecom Namibia Limited operations and will cease to provide telecommunications services that require a licence.
- 4. Further benefits of the transfer of spectrum use license and withdrawal of service licence are that the current Powercom (Pty) Ltd t/a Leo customers will retain their services, as they are been transferred to TN Mobile, which operates under the Telecom Namibia Limited service licence.
- 5. The Authority understands the needs and expectations of the Powercom (Pty) Ltd t/a Leo consumers, especially given the transition that will be brought by the nature of the applications at hand. Therefore most aspects of consumer protection will be monitored on a continuous basis and dealt with in terms of the relevant provisions of the Communications Act and Regulations Regarding Consumer Complaints.
