In terms of section 64(5) of the Electoral Act, 1992 (Act No. 24 of 1992), it is made known that -

- (a) a poll shall take place on 5 August 2014 from 07h00 until 21h00 for the election of a member of the Ohangwena Regional Council in respect of the Ohangwena Constituency;
- (b) the persons whose names, voter registration numbers and residential addresses appear in Column 1 of the Schedule have, in terms of section 64(1), been declared to be duly nominated in respect of the by election of a member referred to in paragraph (a), with an indication of the political party by whom each candidate was nominated; and
- (c) in terms of section 73 of that Act, polling stations have been established, in respect of the election referred to in paragraph (a), at the places mentioned in Column 2 of the Schedule.
