Definitions

1. In these regulations “the Regulations” means the Regulations Relating to Use of Voting Machines at Elections, published under Government Notice No. 117 of 1 August 2014 as amended by Government Notice No. 209 of 2014.

Amendment of regulation 17 of Regulations

2. The Regulations are amended by the substitution for regulation 17 of the following regulation:

“Verification of records by election agents

17. Where the election agents are required under these regulations to verify any recording made by a presiding officer or a returning officer, such verification must be made on Form 5 or 6.”

Amendment of Annexure to Regulations
