TOWNSHIPS AND DIVISION OF LAND ORDINANCE, 1963**

In terms of section 13 of the Townships and Division of Land Ordinance, 1963 (Ordinance No. 11 of 1963), I -

- (a) declare the area being the subdivision of portion 160 (a portion of Portion 5) (a portion of Portion B) of the Farm Swakopmund Town and Townlands No. 41, Registration Division "G" in the Erongo Region and represented by the General Plan No. G232 (S.G. No. A583/2019), to be an approved township; and
- (b) set forth in the Schedule the conditions subject to which the application for permission to establish the township concerned has been granted.
