Nigeria (Constitution) Orders in Council, 1954 to 1960

REVOCATION OF AUTHORITY TO PERFORM FUNCTIONS OF PRIME MINISTER

It is announced for general information that the Officer Administering the Government of the Federation, on the recommendation of the Prime Minister, and in accordance with the provisions of section 102A of the Nigeria (Constitution) Order in Council, 1954 (as amended), has revoked, with effect from the 21st day of May, 1960, the authority given to Alhaji the Honourable MUHAMMADU INUWA WADA, M.H.R., Minister of Works and Surveys, to perform the functions conferred on the Prime Minister by that Order during the absence of the Prime Minister from Nigeria, notification of which was given by Government Notice No. 850 in *Official Gazette* No. 28 of the 12th of May, 1960.

RE-ASSUMPTION OF MINISTER'S RESPONSIBILITY WITHIN NIGERIA

MINISTER OF DEFENCE

It is notified that a modification of the assignment of responsibilities to Alhaji the Honourable Sir ABUBAKAR TAFAWA BALEWA, K.B.E., M.H.R., dated the 4th of May, 1960, and effective while he was absent from Nigeria, has been cancelled with effect from his return to Nigeria on the 21st of May, 1960.

The modification limited his responsibilities to the exercise of the same outside Nigeria. He re-assumes responsibility as Minister of Defence within Nigeria on his return.
