LAGOS LOCAL GOVERNMENT ORDINANCE, 1959

Lagos Town Council (Official List of Voters) Order, 1960

Commencement : 18th February, 1960

In exercise of the powers conferred by rule 11 in the First Schedule to the Lagos Local Government Ordinance, 1959, the Governor-General, after consultation with the Council of Ministers, has made the following Order—

1. This Order may be cited as the Lagos Town Council (Official List of Voters) Order, 1960, and shall apply in respect of the Federal territory of Lagos.

2. The Register of Electors prepared for Lagos for the purpose of elections to the House of Representatives held in the year 1959 shall constitute the official list of voters for the purpose of the bye-election to the Lagos Town Council to be held in March, 1960.

LAND REGISTRATION ORDINANCE (CHAPTER 108)

Land Registration Ordinance (Delegation) (Lagos) Notice, 1960

Commencement : 18th February, 1960

In exercise of the powers conferred by section 3 of the Ministers Statutory Powers and Duties (Miscellaneous Provisions) Ordinance, 1958, the Minister of Lagos Affairs has delegated to the Permanent Secretary, Ministry of Lagos Affairs all those powers under the Land Registration Ordinance which were delegated to the former Permanent Secretary, Ministry of Lagos Affairs, Mines and Power by the Land Registration Ordinance (Delegation) (Lagos) Notice, 1958, published as Legal Notice 168 of 1958, in respect of land situated in Lagos.
