FEDERAL TRAINING CENTRE

APPLICATION FOR ADMISSION AS STENOGRAPHER-IN-TRAINING

Applications are invited from suitably qualified Nigerians who are willing to undertake training as Stenographers Grade II for admission into the Federal Training Centre, Lagos. The duration of the course is twelve months.

2. Applicants must have passed the West African School Certificate or its equivalent and preference will be given to those candidates with credit in English Language.

3. Selected candidates will be required to enter into bonds to serve the Federal Government for a specified period of years after successful completion of their training.

4. Selected trainees for this course will on its completion take the Federal Training Centre final examination in English, Shorthand and typewriting and Secretarial Practice, and on passing in these subjects will be issued with a Federal Republic of Nigeria Government Certificate.

5. The course is not residential, and selected candidates will be paid a salary of $\pounds 174$ per annum while in training. On successful completion of the course, candidates will be offered appointments as Stenographers Grade II on a commencing salary of $\pounds 247$ per annum in Scale D2. There will be opportunity for further training as Stenographers Grade I and Secretary-Typists.

6. Method of applications.—Applications should be addressed to the Permanent Secretary, Nigerianisation Division, Ministry of Establishments, Independence Building, Tafawa Balewa Square, Lagos, to reach him not later than Saturday 7th December, 1963 and should contain the following particulars :—

(i) Full name

(ii) Age and sex

(iii) Present address (and if in employment, name of employer)

(iv) Schools/Colleges attended

(v) Whether married or single

(vi) Only copies of certificates or examinations passed and other documents relating to the applicant's educational qualifications need be enclosed.

(vii) Employment since leaving school or college.

7. Applications from candidates in Government Service, Statutory Corporations should be submitted through the Heads of the applicant's Departments, and be accompanied by confidential reports as to the candidates suitability for the proposed training.

8. Photostat or certified copies of certificates should be forwarded with the application.
