REGISTRATION OF TITLES ACT (CHAPTER 181)

Registration of Titles (Application) (No. 3) Order, 1963

Date of Commencement : 28th February, 1963

In exercise of the powers conferred by subsection 1 of section 2 of the Registration of Titles Act, the Governor-General, acting in accordance with the advice of the Council of Ministers, has made the following order —

1. This Order may be cited as the Registration of Titles (Application) (No. 3) Order, 1963.

2. The Registration of Titles Act shall apply to the area specified in the Schedule hereto.

SCHEDULE

All that parcel of land situate in the Federal Territory of Lagos and known as Victoria Island, Lagos, containing an area of approximately 2.2 square miles, the boundaries of which are described below :

Starting at a point on the South bank of the Five Cowrie Creek where the Ahmadu Bello Road meets the Five Cowrie Creek bridge, the boundary runs along the southern bank of the Five Cowrie Creek in a general easterly direction for an approximate distance of 14,500 feet to a point on the west bank of its confluence with the Magbon Creek ; thence along the western bank of the Magbon Creek in a general south-westerly direction for an approximate distance of 8,200 feet to a point on the West bank of its confluence with the Kuramo Waters (opposite Igbosere Village) ; thence along the northern bank of the Kuramo Waters in a general south-westerly direction for an approximate distance of 3,900 feet to its terminus at Inupa Village ; thence in a southerly direction for an approximate distance of 300 feet to a point on the bank of the Bight of Benin ; thence along the bank of the Bight of Benin in a general westerly direction for an approximate distance of 5,700 feet to a point on the east bank of the east mole ; thence in a westerly direction across the east mole for an approximate distance of 200 feet to a point on the west bank of the east mole ; thence along the east bank of the Lagos Lagoon, through the Wilmot point, in a general northerly direction for an approximate distance of 9,550 feet to a point on the south bank of the Five Cowrie Creek where the Ahmadu Bello Road meets the Five Cowrie Creek bridge, the starting point.
