THE CONSTITUTION OF MID-WESTERN NIGERIA ACT, 1964
(1964, No. 3)

The Constitution of Mid-Western Nigeria Act (Commencement)
Order, 1964

Commencement : 14th January, 1964

In exercise of the powers conferred on me by subsection (3) of section three of the Constitution of Mid-Western Nigeria Act, 1964 and section twenty-two of the Interpretation Act, and of all other powers enabling me in that behalf, I hereby make the following order :—

Cap. 89.

1. I hereby appoint the seventh day of February, nineteen hundred and sixty-four, as the day on which, subject to subsections (1) and (2) of section three of the Constitution of Mid-Western Nigeria Act, 1964 (which provide for certain provisions of that Act to come into force before the appointed day), the said Act of 1964 shall come into force.

Commence-
ment of Act

2.—(1) This order may be cited as the Constitution of Mid-Western Nigeria Act (Commencement) Order, 1964.

Citation and
revocation

(2) The Constitution of Mid-Western Nigeria (Commencement) Order, 1964, is hereby revoked and shall be deemed never to have been made.

EXPLANATORY NOTE

(This note is not part of the order, but is intended to indicate its general purport.)

This order provides that those provisions of the above-mentioned Act which, under the provisions of the Act, did not come into force immediately when the Act became law shall come into force on the 7th of February, 1964.
