THE AGRICULTURE (CONTROL OF IMPORTATION)
ACT, 1959

(1959, No. 28)

Plants (Control of Importation) Regulations, 1964

Commencement : 30th April, 1964

In exercise of the powers conferred on him by Section 4 of the Agriculture (Control of Importation) Act, 1959, and of all other powers enabling him in that behalf, the Federal Minister responsible for Economic Development has made the following regulations:—

1. These regulations may be cited as the Plants (Control of Importation) Regulations, 1964, and shall apply throughout the Federation.

2. In these regulations—

Interpreta-
tion.

"Importer" includes any person who, whether as owner, consignor, consignee, agent or broker, is in possession of, or in anyway entitled to, the custody of any article to which these regulations apply; and,

"Phytosanitary certificate" means a document issued by the recognised plant protection authority or organisation of the country of origin, certifying that the plants or plant products indicated therein have been thoroughly examined before despatch and found to be substantially free from pests and disease.

"Pest" means any insect or other animal injurious to agricultural or horticultural crops;

"Plant disease" means any disease carried by fungus, bacterium virus or other organism injurious to agricultural or horticultural crops;

"Plant" means any plant or parts of a plant such as cuttings, sucker, bulbs, tubers, roots, haulms and fruit; but does not include the manufactured or processed products of plants;

"Special certificate or additional declaration" a certificate or declaration on the phytosanitary certificate worded as specially required:

(a) to certify freedom from disease when inspected during active growth, or

(b) to ensure safeguard against diseases or pests specially mentioned.

"Treatment" means any treatment by immersion, spraying, dusting or fumigation or any other method, prescribed to free the plants or plant products from disease and/or pests.

"Official service" means by or on behalf of, the Federal Plant Quarantine Service.

"Quarantine" means the culture under general conditions of isolation, immediately after introduction into the importing country, or in a selected country outside Africa, under special supervision of the official service, and under conditions as may be recommended by the Inter-African Phytosanitary Commission in order to verify the freedom from plant diseases and pests.

"Prohibit" means to forbid the importation of particular plants or plant products by refusing to authorise their introduction, in accordance with Article 6 of the Inter-African Phytosanitary Convention; on the understanding that, in accordance with Article 8 of the same Convention, this shall not prevent the Official Service from importing such plants or plant products; provided that :—

(a) the importation is a matter of urgency for scientific purposes ;

(b) the importation is undertaken by, or on behalf of, the Official Service itself ;

(c) the maximum necessary precautionary measures, including phytosanitary certificate inspection, treatment and quarantine, are taken ;

(d) the decision to make this special importation, giving reasons and precautionary measures, is communicated to the Scientific Secretary, of the Inter-African Phytosanitary Commission for the information of member countries.

Authorised

3. The Director of Agricultural Research and any officers designated by him (not below the rank of Assistant Technical Officer), are hereby designated as authorised officers for the purposes of these Regulations.

4. With the exception of Items noted as unrestricted, in the First Schedule, no person shall import into Nigeria—

(a) any plants (whether alive or dead and whether or not such are used as packing material) ;

(b) any seeds ;

(c) any soil (other than sterilised peat and special rooting compost) ; or

(d) any material mixed with any soil ; except under and in accordance with the conditions of a permit issued under these regulations by an authorised officer.

5. Application for a permit shall be made in writing to the Plant Quarantine Service, Federal Department of Agricultural Research, Ibadan stating—

(a) full name, residence and postal address of applicant ;

(b) name and address of the person from whom it is proposed to obtain the plants, seeds or soil ;

(c) the botanical name and/or the generally accepted popular name and variety of plants or seeds and the quantity of each variety it is desired to import ;

(d) the locality in Nigeria in which it is proposed to grow or utilise the plants, seeds or soil, as the case may be ;

(e) the port of entry and estimated date of arrival and the means or transportation of the consignment.

Conditions
of permit.

6. (1) The issue of any permit for the purposes of these regulations shall be in the discretion of an authorised officer and may be subject to such conditions as he thinks fit including (without prejudice to the generality thereof) a condition that each consignment be accompanied by a phytosanitary certificate duly completed and signed by or on behalf of a competent authority of the country of origin. The form of the permit shall be as set out in the Second Schedule to these regulations.

(2) An authorised officer shall, in considering an application for a permit, be guided by the list of plants, seeds, soil or similar articles and the conditions attached thereto prescribed in the First Schedule to the regulations.

7. (1) Any consignment of plants, seeds or soil—

(a) imported into Nigeria in contravention of these regulations, or

(b) which an authorised officer may consider undesirable by reason of contamination by plant pests or diseases or noxious weeds, shall forthwith be destroyed or re-exported by and at the expense of the importer.

(2) If any importer shall fail to destroy or re-export any plants, seeds or soil upon being required so to do in accordance with this regulation, any authorised officer may effect such destruction or re-export and any expenses incurred thereby shall be recoverable from the importer.

8. An authorised officer may, upon production if so required of his authority, enter any premises at all reasonable times and examine and take samples of any consignment or part of a consignment of plants, seeds or soil imported or suspected by him of having been imported into Nigeria, and for the purpose of such examination may open or require the importer to open any package in the consignment.

9. Any person who contravenes or fails to comply with any of the provisions of regulations 4 or 7 (1) shall be guilty of an offence and liable on conviction to a fine not exceeding fifty pounds or imprisonment not exceeding six months or to both such fine and imprisonment.

10. The Regulations specified in the first column of the Third Schedule are hereby revoked to the extent specified in the second column of that Schedule.

8. CHESTNUT (*Castanea vulgaris*)*Vegetative material :*

Permit, phytosanitary certificate, special certificate or additional declaration of active growth inspection and stating that chestnut canker (*Endothia parasitica*) is not known to occur in the country of origin.

As for vegetative material

9. CITRUS

Vegetative material :(a) *rooted material :*

Prohibited.

(b) *unrooted material :*

Prohibited from countries where citrus canker is known to occur. From other countries : by Official Services, only, phytosanitary certificate, special certificate or additional declaration of active growth inspection, and for citrus canker and, if possible, quarantine.

Permit, phytosanitary certificate, special certificate or additional declaration of active growth inspection, and for citrus canker, treatment with hydrogen peroxide.

Fruits :

(a) From countries where citrus canker or Oriental Fruit Fly (*Dacus dorsalis*) occurs : Prohibited.

(b) From countries where Mexican Fruit Fly (*Anastrepha ludens*) A. *fraterculus* or West Indian Fruit Fly (*A. mombinpraeoptans*) are known to occur : permit, phytosanitary certificate inspection an animal and treatment if necessary.

(c) From other countries : Unrestricted.

10. CLOVER (*Trifolium* spp.)*Vegetative material :*

Prohibited.

Seeds :

Permit, phytosanitary certificate, treatment.

Fodder or meal :

Prohibited.

11. COCONUT

Vegetative material :

From New World (North, South and Central America and the West Indies), Seychelles, Madagascar and Philippines : prohibited. From other countries : permit, phytosanitary certificate, special certificate (active growth) and quarantine.

Seeds for planting :

From New World, seychelles, Madagascar and Philippines : prohibited. From other countries : permit, phytosanitary certificate.

12. COFFEE (*Coffea* spp.)*Vegetative material :*

(Official Services only, phytosanitary certificate, special certificate or additional declaration of inspection in active growth and quarantine.

Seeds for planting :

From New World : as for vegetative material. From elsewhere : (Official Services only, phytosanitary certificate, special certificate of inspection of parent trees in active growth.

Fruits (Cherries) :

Prohibited.

Unroasted coffee beans for consumption :

Permit, inspection, treatment if necessary.

13. CONIFERS

Vegetative material :

(a) From Australasia : Official Services only, Phytosanitary Certificate and quarantine.

(b) From all other countries : Prohibited.

Official Services only, treatment.

Permit, phytosanitary certificate, special certificate or additional declaration of active growth inspection and for virus diseases, quarantine.

Permit, phytosanitary certificate, special certificate (active growth).

(b) From countries where Apple Maggot (*Rhagoletis pomonella*) Cherry Fruit Fly (*R. cerasi*), Mexican Fruit Fly (*Anastrepha ludens*) or *A. fraterculus* is known to occur : (for relevant fruits) phytosanitary certificate, inspection on arrival and treatment if necessary.

(c) From other countries : Unrestricted.
Peach and Nectarine : prohibited.
Other seeds : unrestricted.

43. RUBBER TREES (*Hevea* spp.)

Vegetative materials :

(a) From America and countries where *Dothidella ulei* is known to occur : Official Service only quarantine in a station outside the African continent (but not in a country where *Dothidella ulei* occurs), followed by a second quarantine within the African Continent.

(b) From countries where *Dothidella ulei* is not known to occur (Asia, Indonesia, Pacific Islands) ; Permit, phytosanitary certificate treatment in the exporting country quarantine within the African Continent.

Seeds :

- (a) From America and other countries where *Dothidella ulei* is known to occur : Official Service only, phytosanitary certificate, disinfection in the exporting country disinfection and destruction of packing material in a country outside the African Continent where *Dothidella ulei* does not occur, quarantine inside the African Continent.

Official Services only, phytosanitary certificate, special certificate or additional declaration of active growth inspection and for virus and bacterial diseases, quarantine.

Seeds :

Official Services only, inspection.

49. SWEET POTATOES (*Ipomoea batatas* and *Ipomoea* spp).

Vegetative material for planting :

Official Services only, phytosanitary certificate, special certificate or additional declaration of active growth inspection and to state that the region of origin is free from Internal Cork virus disease, quarantine.

Tubers for consumption :

Prohibited.

Seeds :

Unrestricted.

Plants, etc.

Conditions, etc.

50. TEA (*Thea assamica*)
Vegetative material
and seeds : Prohibited.
51. TOBACCO (*Nicotiana* spp.)
Vegetative material : Prohibited.
Seeds : From areas where Blue Mould (*Peronospora tabacina*) occurs: Prohibited. From other areas: Permit, phytosanitary certificate, special certificate of additional declaration of active growth inspection and to state that *Peronospora tabacina* does not occur in the area of origin, treatment.
52. TOMATOES (*Solanum lycopersicum* and other spp.)
Vegetative material: Prohibited.
Seeds : Permit, phytosanitary certificate, special certificate or additional declaration and to state that the fields of origin were free from Tomato Canker (*Corynebacterium michiganense*)
53. WHEAT (*Triticum* spp.) See Small Cereals, namely Barley, Wheat, Oats, Rye (No. 56)
54. WILD PLANTS AND PLANTS NOT SPECIALLY MENTIONED IN PROPOSALS.
Vegetative material and seeds : Permit, inspection and treatment if necessary.
55. YAM (*Dioscorea* spp.)
Vegetative material : Permit, phytosanitary certificate, special certificate (active growth).
Seeds : Unrestricted.
56. SMALL CEREALS namely Barley, Wheat, Oats, Rye.
Vegetative material : Prohibited.
Seeds for planting : Permit, and treatment.
57. BULBS, TUBERS, RHIZOMES AND OTHER SUBTERRANEAN PARTS FOR PROPAGATION OF ORNAMENTALS AND OTHER PLANTS (except Potatoes and Sweet Potatoes)
Permit, phytosanitary certificate, special certificate or additional declaration of active growth inspection and for serious nematodes.
58. FRESH FRUITS (excluding Rosaceae and Citrus)
(a) From Asia (East of 60 E Longitude) the Pacific Islands, and other countries where Oriental Fruit Fly (*Dacus dorsalis*) occurs: Prohibited.

Unrestricted.

60. SOILS AND COMPOSTS

Soils :

(a) For scientific and analytical purposes: Permit, treatment (sterilisation) after use.

(b) For rooting or packing: Prohibited.

Sterilised special rooting compost, sphagnum or peat :

Unrestricted.

61. OTHER ORGANISMS
