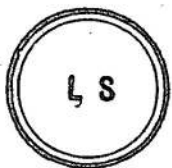

A BILL for an Act to authorise the issue out of the Consolidated Revenue Fund of seventy-eight million, three hundred and ninety-six thousand three hundred and seventy pounds for the service of the year ending on the thirty-first day of March, one thousand nine hundred and sixty-six: and to appropriate that amount for the purposes specified in this Act.	The Bill provides for the making of payments from the Consolidated Revenue Fund to defray so much of the estimated non-capital expenditure of the Government of the Federation during the financial year 1965-66 as is not already charged on that or any other public fund.	4-5-65	5-5-65

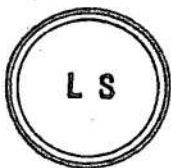

A BILL for an Act to confer summary jurisdiction on Magistrates in respect of dangerous drugs.	The Bill seeks to confer jurisdiction on all Magistrates throughout the Federation for the summary trial of any offence against the Dangerous Drugs Act and for the imposition of the penalty provided by the Act for that offence.	1-4-65	28-4-65
A BILL for an Act to regulate the exercise by the High Court of Lagos of its Admiralty Jurisdiction.	The Bill intends to stipulate the law and procedure to be followed by the High Court of Lagos in the exercise of its admiralty jurisdiction in respect of the Federal Territory of Lagos.	1-4-65	28-4-65
A BILL for an Act to alter the composition of the University College Hospital Board of Management.	The purpose of the Bill is to increase the membership of the Management Board of the University College Hospital, Ibadan, in order to reflect recent constitutional changes.	1-4-65	29-4-65

A BILL for an Act to extend the Pool Betting Tax Act, 1962 to Northern and Eastern Nigeria; to provide for the cancellation of pool betting licences of persons convicted of certain offences; and to amend section 1 (2) of the said Act and section 2 (2) of the Pool Betting Act, 1963.	The Bill seeks to extend the application of the Pool Betting Tax Act, 1962 to Northern and Eastern Nigeria, and to empower a court to cancel a licence issued under the Pool Betting Control Act, 1961 if the holder is convicted of an offence under the Pool Betting Tax Act.	2-4-65	1-5-65
A BILL for an Act to amend certain provisions of the Nigerian Army Act, 1960, The Navy Act, 1964 and the Air Force Act, 1964 expressed in terms inappropriate to monthly rates of pay.	The Bill amends the Nigerian Army Act, 1960, the Navy Act, 1964 and the Air Force Act 1964 by expressing the punishments, forfeitures and deduction of pay which are described in terms of a daily rate in those Acts, in terms appropriate to monthly rates of pay.	2-4-65	1-5-65
A BILL for an Act to make provision with respect to hire-purchase and credit-sale transactions and the advertisements relating thereto; and for purposes connected with the matters aforesaid.	The Bill makes provision for the regulation of hire-purchase and credit-sale transactions. It affords protection to the buyer of goods on hire-purchase or similar terms against certain abuses which have become apparent in the practice of hire-purchase trading and secures that the owner is not put at an undue disadvantage.	5-5-65	6-5-65

A BILL for an Act to authorise the issue out of the Consolidated Revenue Fund of four hundred and thirty-five thousand nine hundred and twenty-three pounds for the purpose of making further provision for the service of the year which ended on the thirty-first day of March, one thousand, nine hundred and sixty-four; and to appropriate that sum for the purposes specified in this Act.	The Bill makes final supplementary provision for the service of the Federation for the financial year 1963-64.	4-5-65	5-5-65
A BILL for an Act to regulate the profession of Accountancy and for Related matters.	The object of the Bill is to regulate the professional activities of qualified accountants throughout the Federation. Provisions are made for the obligatory registration of all accountants with the proposed Institute of Chartered Accountant, the establishment of a Governing Council to direct the affairs of the Institute and determine its policy and a Disciplinary Tribunal to adjudicate on cases of professional misconduct against members.	4-5-65	5-5-65
BILL for an Act to amend the Prisons Act 1960.	The Bill seeks to amend the Prisons Act 1960 to give authority to an Assistant Director of Prisons to give consent to the transfer of prisoners from Native Authority or Local Government Prisons or lock-ups to Federal Government Prisons.	4-5-65	5-5-65
A BILL for an Act to make provision for the licensing and control for excise purposes of the refining of hydrocarbon oils and for matters incidental thereto or connected therewith.	The Bill provides for the licensing and control for, excise purposes only, of the refining of hydrocarbon oils as well as the disposal of, and collection of excise duty on, such oils.	4-5-65	5-5-65

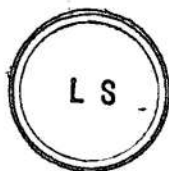

A BILL for an Act to amend the External Loans Act, 1962.	The Bill seeks to widen the scope of the External Loans Act, 1962 by enabling the Minister to raise loans outside Nigeria without giving securities in the form of promissory notes as required by the Government Promissory Notes Act, 1960.	1-4-65	30-4-65
A BILL for an Act to exclude the operation in Northern Nigeria of sundry references to assemblies and processions in the Police Act.	The Bill provides that sections 27 to 30 of the Police Act (Chapter 154 of the Laws of the Federation and Lagos 1958) shall not apply to Northern Nigeria. Those sections relate to the control of assemblies and processions, matters which are now dealt with there by sections 6 to 8 of the Public Order (Amendment) Law 1964 of Northern Nigeria.	1-4-65	30-4-65
A BILL for an Act to make further provision for the custody of children whose welfare is endangered by disputes; to provide for the continuation of contribution towards the maintenance of a young person where the original contributor dies; to remove a doubt as to the amount of contributions which may be required in respect of children and young persons in pursuance of the Children and Young Persons Act; and for purposes connected with the matters aforesaid.	The Bill amends certain sections of the Children and Young Persons Act, Cap. 32 of the Laws of Nigeria, 1958 with a view to providing for the security of children whose welfare has been threatened by contentions or quarrels between parents and for the maintenance of children in custody after the death of the persons liable to contribute towards their maintenance.	1-4-65	1-5-65

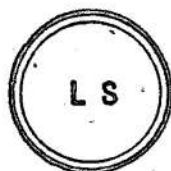

<i>Long Title of Bill</i>	<i>Summary of Contents</i>	<i>Date passed by House of Representatives</i>	<i>Date passed by Senate</i>
A BILL for an Act to validate certain marriages in Northern Nigeria and for connected matters.	The Bill seeks to resolve doubts which have arisen in Northern Nigeria as to the validity of marriages celebrated there under the Marriage Act, as from 1961 due to changes in the titles of certain public officers and other causes, by declaring the marriages concerned to be valid.	1-4-65	29-5-65
A BILL for an Act to amend the Customs and Excise Management Act, 1958 by making provision in certain cases for the retention of records by the Police; and for the avoidance of doubts as to the exercise of the right of appeal by a prosecutor in particular cases.	The Bill confers, in respect of offences under the Customs and Excise Laws, power to retain for record purposes and subsequent use, measurements, photographs, or fingerprint impression of persons in lawful custody; and on a prosecutor to appeal to a superior court against any decision of a court of summary jurisdiction.	1-4-65	29-4-65
A BILL for an Act to make provision for the granting of relief from income tax on rents received in respect of certain dwelling houses; and for purposes connected therewith.	The Income Tax (Rents) Act, 1963 enabled the Minister of Finance to grant relief from income tax on rents accruing to a Federal taxpayer in respect of certain dwelling houses built in Lagos. In the case of rents received in advance the relief was limited to one single receipt. Under the Act an election could not be made in respect of an eligible property if such an election had previously been made by any person in respect of that property or any part of it. This Act seeks to remove the first of these limitations, and to modify the second one so as to enable the cost of construction of an eligible property to be recouped before tax becomes payable on the rents therefrom; and provides that the excess (if any) of rent received (whether in advance or otherwise) over the cost of construction, or over the balance in respect of which relief has not been granted, as the case may be, shall be liable to tax as income of the year in which the rent is received. The Income Tax (Rents) Act, 1963 is accordingly repealed.	1-4-65	30-4-65
