National Premium Bonds (Amendment) Regulations 1965

Commencement : 1st December 1965

In exercise of the powers conferred by subsection (3) of section 1 of the Savings Bonds and Certificates Act, 1962 and of all other powers enabling me in that behalf, I hereby make the following regulations—

1. (1)—These regulations may be cited as The National Premium Bonds (Amendment) Regulations 1965.

(2) These regulations shall apply throughout the Federation and shall come into operation on the 1st day of December 1965.

2. Regulation 3 of the National Premium Bonds Regulations 1963 is hereby amended as follows-

(i) by the insertion after the word "and" where it appears in subsection (2) of the word "at".

(ii) by the addition of the following new subparagraph-

"3 (2) (a) Bonds may also be purchased from any person appointed to be a sales agent by the Director."

3. Regulation 26 of the National Premium Bonds Regulations 1963 is hereby amended as follows--

(i) by the deletion of the word "and" where it appears in paragraph (a)

(ii) by renumbering regulation "26 (b)" as regulation "26 (c)", and by the deletion therefrom of the word "for".

(iii) by the addition of the following new subparagraph-

"(b) subject to the approval of the Minister conditions relating to the appointment, reappointment and dismissal of sales agents; and"

"(3) The Director may appoint any person to be an agent for the sale of certificates".

3. Regulation 33 of the Savings Certificates Regulations 1963 is hereby

(i) by the deletion from regulation 33 (a) of the word "and";

(ii) by renumbering regulation "33 (b)" as regulation "33 (c)" and the deletion therefrom of the word "for"

(iii) by the insertion after regulation 33 (a) of the following new subparagraph—

"(b) subject to the approval of the Minister conditions relating to the appointment, reappointment and dismissal of agents for the sale of dertificates; and"
