LAGOS TOWN PLANNING ACT (CHAPTER 95)

Lagos Town Planning (Re-Declaration of Planning Area) Order 1966

Commencement : 28th February 1966

In exercise of the powers conferred by section 17 of the Lagos Town Planning Act as modified by the Constitution (Suspension and Modification) Decrees 1966 (Nos. 1 to 9) which powers have been delegated to me under the Military Administrator of the Capital Territory (Delegation of Powers) Notice 1966 (L.N. No. 68 of 1966) and of all other powers enabling me in that behalf, I hereby make the following Order :—

1. This Order may be cited as the Lagos Town Planning (Re-declaration of Planning Area) Order 1966 and shall be deemed to have come into operation on the 28th day of February, 1966.

2. All that area of the City of Lagos described in Section 2 of the Lagos Town Planning (Re-declaration of Planning Area) Order in Council 1947, but excluding therefrom the areas referred to in the Schedule to this Order, is hereby re-declared to be a town planning area.

THE NATIONAL HONOURS ACT 1964

The Honours (Armed Forces) (Amendment) Warrant 1966
